

## CHAPTER 566—H. F. No. 1289

[Coded]

*An act transferring administrative control of certain lands in Lake county from the department of highways to the department of conservation.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **[85.195] Flood Bay Wayside Park.** Administrative control over the following described state-owned lands, situated in Lake county, is hereby transferred from the department of highways upon payment to the trunk highway fund the sum of one dollar to the department of conservation, to-wit:

Government lot 1, section 32, township 53, range 10, which lies southeasterly of a line run parallel with and distant 300 feet southeasterly of the center line of trunk highway No. 61, formerly known as trunk highway No. 1, as same is now located and established over and across said section 32, together with all that part of the following described tract:

Government lot 2, section 32, township 53, range 10, which lies southeasterly of a line run parallel with and distant 250 feet southeasterly of the center line of said trunk highway No. 61 and northeasterly of the following described line: Beginning at the northwest corner of said government lot 2; thence run southeasterly at an angle of 59° with the west line of said section 32 to its intersection with the low water mark of Lake Superior and there terminating; excepting therefrom the right of way of existing highway and subject to mineral reservations of record, containing 18.65 acres, more or less.

These lands are hereby dedicated as "Flood Bay Wayside Park" to be administered under the supervision and control of the commissioner of conservation as provided by law for state parks, or state waysides.

CHAPTER 567—H. F. No. 1374

*An act relating to elections; corrupt practices; amending Minnesota Statutes 1961, Chapter 211, as amended, by adding a section thereto.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Chapter 211, as amended, is amended by adding a section thereto to read:

**[211.081] Elections; false claim of party support.** *No person or candidate shall knowingly, either by himself or by any other person, while such candidate is seeking a nomination or election, make, directly or indirectly, a false claim stating or implying that the candidate has the support or endorsement of any political party, or unit thereof, or of any organization, when in fact the candidate does not have such support or endorsement.*

CHAPTER 568—H. F. No. 1379

*An act relating to notice of expiration of period of redemption of lands sold at tax sale.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Tax sales; redemption; notice.** When any notice of expiration of redemption of the period during which any person claiming an interest in any parcel of land sold for taxes at a tax sale held prior to January 1, 1962 or bid in by the state of Minnesota at any such sale and held or assigned by said state subsequent to such sale may redeem the same under the provisions of Minnesota Statutes, Chapter 281, as amended, has been served upon the commissioner of public welfare within the period specified in said chapter for the serving of such notice, such notice shall be considered as having been served upon the state of Minnesota and shall have the same force and effect as though it had been served upon the attorney general of said state in all instances where an old age assistance lien involving such parcel was held by the state of Minnesota at the time of such service.
