CHAPTER 613—S. F. No. 2003

*An act relating to tax levies in Le Sueur county for general revenue purposes and for the county road and bridge fund.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Le Sueur county; road and bridge tax levies.** Notwithstanding the provisions and limitations of any law to the contrary, the board of county commissioners of Le Sueur county may:

(1) Levy annually a tax not to exceed 20 mills on the dollar of the taxable valuation of the county for general revenue purposes; and

(2) Levy annually a tax not to exceed 25 mills on the dollar of the taxable valuation of the county for the county road and bridge fund.

Sec. 2. This act shall become effective upon its approval by the board of county commissioners of the county of Le Sueur and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

*An act relating to Independent School District No. 16; authorizing the issuance of bonds; amending Laws 1965, Chapter 27, Section 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1965, Chapter 27, Section 1 is amended to read:

Section 1. **Independent School District No. 16; building bonds.** Notwithstanding the limitations of Minnesota Statutes 1961, Section 475.53, and without being required to comply with Extra Session Laws 1959, Chapter 27, Section 8, Subdivision 6, Independent School District No. 16 is hereby authorized to issue and sell its bonds in an aggregate amount not to exceed \$3,500,000 \$5,500,000 over and above indebtedness heretofore incurred by it and any loans made to it under said chapter 27, for the purpose of acquisition and betterment of schoolhouses. Approval of the voters shall be required to authorize such bonds in the manner provided by law. Such bonds may be sold and issued in such amounts and at such times as may be determined by the school board; provided, that if prior to issuing any of such bonds the district obtains any capital loan or loans under chapter 27, the amount of bonds authorized hereby shall be deemed to be reduced by the amount of such loan or loans.

Sec. 2. *This act is effective upon its approval by the school board of Independent School District No. 16, and upon compliance with the provisions of Minnesota Statutes, Section 645.021.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Independent School District No. 14; building bonds.** Notwithstanding the limitations of Minnesota Statutes 1961, Section 475.53, and without being required to comply with Extra Session Laws 1959, Chapter 27, Section 8, Subdivision 6, Independent School District No. 14 is hereby authorized to issue and sell its bonds in an aggregate amount not to exceed \$2,000,000 over and above indebtedness heretofore incurred by it and any loans made to it under said Chapter 27, for the purpose of acquisition
