

and betterment of schoolhouses. Approval of the voters shall be required to authorize such bonds in the manner provided by law. Such bonds may be sold and issued in such amounts and at such times as may be determined by the school board; provided, that if prior to issuing any of such bonds the district obtains any capital loan or loans under said chapter 27, the amount of bonds authorized hereby shall be deemed to be reduced by the amount of such loan or loans.

Sec. 2. The district may levy the taxes required by law for the payment of such bonds or loans and interest thereon without limitation as to rate or amount, and the levy of such taxes shall not cause the amount of other taxes, levied or to be levied by the district, which are subject to any such limitation, to be reduced in any amount whatsoever.

Sec. 3. This law shall become effective only after its approval by a majority of the members of the school board of said district, and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

CHAPTER 616—S. F. No. 2031

An act relating to Aitkin county; providing for separate account for the Aitkin county Long Lake conservation training center.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Aitkin county; Long Lake conservation training center.** Notwithstanding the provisions of Minnesota Statutes, Section 398.33, all moneys, fees, and donations specified for or received from the operation of the Aitkin county long lake conservation training center shall be deposited in a separate account, other than the park fund, to be under the jurisdiction of the secretary-treasurer of the Aitkin county park commission. Such secretary-treasurer so appointed shall give a corporate surety bond to the county in such sum as the county board may direct, but for not less than \$1,000, conditioned for the faithful performance of his official duties, expenses of such bond shall be paid by the county, and shall be approved and filed as provided by law for bonds of county officers.

The secretary-treasurer shall make a comprehensive report of the funds received, paid out, and on hand. Such report shall be submitted by the secretary-treasurer by certified copy as prescribed by the public examiner, to the register of deeds of the county and the state auditor on or before the first day of November of each year. All books and affairs of the Long Lake conservation training center, to the extent the center receives aid from appropriations, shall be subject to examination by the public examiner for the current year. This act in no way restricts the transferring of annual profits from the operation of the conservation training center to the park fund for other park activities.

Sec. 2. This act is effective when approved by the county board of Aitkin county, and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 617—S. F. No. 2036

An act relating to the towns of Lawrence and Iron Range in Itasca county; authorizing the town of Lawrence to join a cemetery association and authorizing tax levies.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Itasca county towns; cemetery association.** The town of Lawrence in Itasca county is authorized to join the Lakeview Cemetery Association operated by the town of Iron Range. The town of Lawrence may pay to the association the sum of \$750 upon joining and may pay such amount not to exceed \$1,000 annually as may be determined by the association. The town of Lawrence may levy for cemetery purposes an amount sufficient to produce \$1,000 annually.

Sec. 2. This act is effective upon its approval by the board of supervisors of the towns of Lawrence and Iron Range and upon compliance with Minnesota Statutes, Section 645.021.
