

CHAPTER 629—S. F. No. 1875

An act relating to the salaries and expenses of the county commissioners of Dakota county; amending Laws 1961, Chapter 249, Sections 1 and 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1961, Chapter 249, Section 1, is amended to read:

Section 1. **Dakota county; commissioners' salaries.** The yearly ~~salaries~~ salary of the members each member of the board of county commissioners of Dakota county shall be set by said board at a sum not to exceed \$4,800, which sum shall be payable in equal monthly installments.

Sec. 2. Laws 1961, Chapter 249, Section 2, is amended to read:

Sec. 2. **Dakota county, commissioners' expense.** Each member of the board of county commissioners shall be allowed a sum not to exceed \$600 ~~\$1,000~~ per year, which said sum shall be payable in equal monthly installments as and for expense account.

Sec. 3. *This act shall become effective only after its approval by the board of county commissioners of Dakota county and upon compliance with Minnesota Statutes, Section 645.021.*

CHAPTER 630—S. F. No. 1895

An act relating to Independent School District No. 489, authorizing the issuance of bonds of the district to repair, alter and equip school buildings.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Independent School District No. 489; bonds.** Independent School District No. 489, comprising the village of Randall and other territory in Morrison county, is authorized to issue general obligation bonds in an amount not to exceed \$100,000, over

and above the amount of all other bonds authorized, issued, or issuable by it pursuant to law, to provide funds for the repair, alteration, and equipment of school buildings. No election shall be required for the authorization of these bonds.

Sec. 2. The bonds shall be issued and sold in accordance with Minnesota Statutes, Chapter 475, except as otherwise provided in this act.

Sec. 3. This act shall become effective only after approval by a majority of the members of the school board of Independent School District No. 489 in Morrison county, and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

CHAPTER 631—S. F. No. 1976

An act relating to Scott county; providing for compensation of certain officials and for deputies and clerk hire.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Scott county; officials' salaries.** Scott county shall pay each of the following officials designated in this section an annual salary of not less than \$7,000, to be determined by the board of county commissioners: County auditor, county treasurer, sheriff, register of deeds, and clerk of district court.

Sec. 2. All fees collected by the officials named in section 1 shall be paid to the county in the manner and at the times prescribed by the county board, and no such official shall receive any such fees as additional compensation.

Sec. 3. The provisions of section 1 and 2 shall take effect with respect to each county office affected thereby upon the expiration of the term of the present incumbent thereof, or upon the occurrence prior thereto of a vacancy in such office.

Sec. 4. The officials named in section 1 shall appoint deputies and clerks in accordance with law, and the county board shall appropriate funds for payment of salaries of deputies and clerk hire.
