CHAPTER 700—S. F. No. 318

[Not Coded]

*An act relating to the salaries of the auditor and treasurer of Cottonwood county.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Cottonwood county; officials; salaries.** Notwithstanding the provisions of any other law to the contrary, the annual salary of the county auditor and county treasurer of Cottonwood county shall each be set by the board of county commissioners in an amount not less than \$6,500 nor more than \$7,500 per year.

Sec. 2. The aforesaid salary shall constitute the base salary and the auditor and treasurer shall be entitled to any cost of living increases hereafter granted under the provisions of Minnesota Statutes, Section 375.43, and acts amendatory thereof or supplementary thereto.

Sec. 3. Nothing contained in section 1 shall be construed as limiting the right of the auditor and treasurer to collect and retain fees, per diem payments, or any other payment which they are now authorized to collect in addition to the stated amount of their monthly salary.

Sec. 4. This act takes effect when approved by the county board of Cottonwood county and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 701—S. F. No. 1350

*An act relating to the state employees retirement association; amending Minnesota Statutes 1961, Section 352.38, Subdivision 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 352.38, Subdivision 1, is amended to read:

**352.38 State employees retirement; former members; service allowances.** Subdivision 1. **Qualifications.** Any former member of the state employees retirement association having ten or more years of allowance service credit as a member thereof who made his application for retirement benefits prior to July 1, 1949, shall receive a service allowance of \$5 per year for each full year of allowable service. This service allowance shall be added to such former member's annuity payments but when so added shall not exceed the maximum retirement benefits provided by law at the time of such person's retirement; *but no payments under this section shall be made to the representative, beneficiary or legal representative of the estate, if any, of those former members who died between July 1, 1957, and June 30, 1958, in those cases where no request or application for such allowance was or is made prior to January 1, 1966.*

CHAPTER 702—S. F. No. 1410

*An act appropriating money to the department of business development to pay expenses of sending the Minnesota over 60 band to perform at the New York World Fair and at the national capitol in Washington, D. C.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Senior citizens band; world fair appropriation.** The sum of \$2,750 is appropriated from the general revenue fund to the department of business development for the purpose of promoting the state of Minnesota by paying expenses of the "Minnesota Senior Citizens' Band", headquartered at Gaylord, Minnesota, for appearances at the World Fair at New York City and the national capitol at Washington, D. C.

Sec. 2. This act is effective upon final enactment.
