

CHAPTER 745—S. F. No. 1012

An act relating to the salaries of the auditor and treasurer of Wabasha county; amending Laws 1963, Chapter 431, Section 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1963, Chapter 431, Section 1, is amended to read:

Section 1. **Wabasha county; auditor and treasurer; salaries.** The board of county commissioners of Wabasha county shall set the annual salary of the county auditor and county treasurer at not less than \$6,500 ~~or more than \$7,500.~~

Sec. 2. *The aforesaid salary shall constitute the base salary and the auditor and treasurer shall be entitled to any cost of living increases hereafter granted under the provisions of Minnesota Statutes, Section 375.43, and acts amendatory thereof or supplementary thereto.*

Sec. 3. *Nothing contained in section 1 shall be construed as limiting the right of the auditor and treasurer to collect and retain fees, per diem payments, or any other payment which they are now authorized to collect in addition to the stated amount of their monthly salary.*

Sec. 4. *This act takes effect when approved by the county board of Wabasha county and upon compliance with Minnesota Statutes, Section 645.021.*

CHAPTER 746—S. F. No. 1060

An act relating to the compensation of certain county officials in the county of Winona.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Winona county; officials; compensation.** The county of Winona shall pay to each county official designated in this section as full compensation for all services rendered by them,

annual salaries to be determined by the board of county commissioners, but shall not be less than the following:

County auditor	\$8,000
County treasurer	8,000
Sheriff	9,500
Clerk of district court	8,000
Register of deeds and registrar of titles, being one office	8,000

Sec. 2. The officials named in section 1 shall charge and collect all fees and per diems prescribed by law and all such fees and per diems shall be paid to the county in the manner and at the times prescribed by the county board. This section shall not affect any actions or proceedings that have been or are pending in the district court for Winona county on the effective date of this act.

Sec. 3. The salary of the officials named in section 1 when set pursuant to the provisions of said section shall constitute a base salary and such officials shall be subject to any cost of living adjustment hereafter made pursuant to the provisions of Minnesota Statutes, Section 375.43 and acts amendatory thereof or supplemental thereto.

Sec. 4. The board of county commissioners shall by resolution determine the number of deputies assigned to each office, and the number of clerks and other employees required in the performance of each respective office, and shall determine and provide for the compensation of each.

Sec. 5. In addition to the salaries and compensation to be paid officials, deputies, clerks, and employees as provided in this act, the board of county commissioners shall by resolution provide for the payment of premiums of any bonds required of any official, deputy, clerk, or employee designated in this act.

Sec. 6. This act shall take effect on January 2, 1967.

Sec. 7. All laws now in force relating to compensation or fees of the county officials to which this act applies inconsistent herewith are hereby repealed and superseded.

Sec. 8. This act takes effect when approved by the county board of Winona county and upon compliance with Minnesota Statutes, Section 645.021.
