Be it enacted by the Legislature of the State of Minnesota:

- Section 1. South St. Paul, city of; land annexation. All proceedings taken by and before the Minnesota municipal commission and the city council of the city of South St. Paul in 1964 for the annexation of a certain tract of land formerly in the town of Inver Grove in Dakota county, as described in ordinance No. 586 of the city, are hereby legalized and validated, notwithstanding any defects or omissions in such proceedings.
- Sec. 2. This act shall take effect upon approval by a majority of the city council of the city of South St. Paul and of the board of supervisors of the town of Inver Grove, and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 8—H. F. No. 352

An act relating to the city of South St. Paul and the town of Inver Grove in Dakota county providing for the extension of the corporate limits of said city to include certain lands now within the limits of said town.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. South St. Paul, city of; extension of corporate limits. The corporate limits of the city of South St. Paul are hereby extended to include certain tracts and parcels of land which are now within the limits of the town of Inver Grove in Dakota county, said tracts and parcels of land being described as follows:

The West ½ of the Northeast ¼, Section 3, Township 27, Range 22; and that portion of the East ½ of the Northwest ¼ of said Section 3, described as follows: Beginning at the ¼ Section corner of the North boundary of Section 3; thence West, along said North boundary 353.37 feet to a point; thence South on a line parallel to the East boundary of said Section 3, to a line 527 feet North of and parallel to the latitudinal center line of Section 3; thence West along said line 527 feet north of and parallel to said latitudinal center line, 395.79 feet to a point; thence South parallel to the East line of the West ½ of the Northeast ¼ a distance of 527 feet to a point on the latitudinal center line of Section 3; thence East along said center line to the longitudinal center line of Section 3; thence North along said longi-

tudinal center line to the point of beginning, containing 96.63 acres, more or less. The Southeast quarter of the Northwest quarter of the Southeast quarter of Section 3, Township 27, Range 22, containing 10 acres, more or less.

All of Blocks 9-10-11 and Lot 1, Block 12, Bushnell's 1st Addition to Inver Grove Park, containing 18.57 acres, more or less.

The South half of the Southwest Quarter of the Southeast quarter; and the East 353.37 feet of the South half of the Southeast quarter of the Southwest quarter; all in Section 34, Township 28, Range 22, containing 25.35 acres, more or less.

Beginning at a point on the West line of the Southeast ¼ of Section 3, Township 27, Range 22, said point being 659 feet North of the Southwest corner of said SE ¼; thence East a distance of 658.00 feet to the point of beginning; thence continuing East a distance of 331.04 feet; thence North a distance of 657.93 feet; thence West a distance of 331.04 feet; thence South a distance of 657.93 feet to the point of beginning, said parcel containing 5 acres, more or less.

Beginning at a point 35 chains, 74 links east from the Northwest corner of the Southeast quarter of the Southwest quarter of Section 3, Township 27, Range 22, thence East 7 chains, 61 links, thence South 9 chains and 91 links, thence West 7 chains, 61 links, thence North 9 chains and 91 links to the place of beginning, containing 7.5 acres, more or less. Outlots A and B of South Grove No. 4, containing 15.65 acres, more or less.

All of Hemmingsen Addition, containing 15.77 acres, more or less.

The North Half of the Southwest quarter of the Southeast quarter of Section 34, Township 28, Range 22, containing 20 acres, more or less. The Northeast Quarter of the Northwest Quarter of the Southeast Quarter of Section 28, Township 28, Range 22, containing 10 acres, more or less.

Sec. 2. This act shall become effective upon approval by a majority of the council of the city of South St. Paul and a majority of the board of supervisors of the town of Inver Grove, and upon compliance with Minnesota Statutes, Section 645.021.
