CHAPTER 829—S. F. No. 2034

[Not Coded]

*An act relating to the operation of state government; providing for public buildings of the state of Minnesota; authorizing the alteration, repair, rehabilitation of said buildings, the equipping and the replacement of equipment of certain of said buildings; appropriating money therefor.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Public buildings; repair, etc.; appropriation.** Except as otherwise provided in this act, the sums hereinafter set forth, or so much thereof as may be necessary, are hereby appropriated out of the general revenue fund in the state treasury or such other funds as designated, for the purposes specified in the following sections of this act.

Sec. 2. Subdivision 1. To the commissioner of public welfare to be expended for the purposes and in accordance with the provisions of this act:

Subd. 14. At Owatonna State School:

(1) Clean and paint water tower and tank; repairs to cottages and other buildings; demolish old buildings 30,000

Subd. 15. At Minnesota School for the Deaf:

(1) Enclose stairway in Mott Hall and install fire door with automatic closer 1,000

Subd. 16. At Braille and Sight Saving School:

(1) Fireproof floors, install new doors and frames, East and West cottages; remodel vocational building 35,000

Subd. 17. At Gillette State Hospital for Crippled Children:

(1) Remove skylights over basement tunnels and close with concrete; replace iron picket fence around six window wells; enclose windows in swimming pool with glass block and improve ventilation; install vinyl floor in living areas of east and west central wings 5,500

Sec. 3. Subdivision 1. To the commissioner of corrections to be expended for the purposes and in accordance with the provisions of this act:

(1) Reroof north dining room; install concrete slab on courtyard; repointing masonry; resurfacing roads; replaster and repaint inmate cells; fluorescent lights in administrative offices, library and school rooms; renew plumbing in cell house D; repair and reroof main penal camp building at Moose Lake; quarry stone production for building projects 59,100

## Subd. 3. At Minnesota State Prison:

(1) Tuckpointing; repairs to food service building; replace flooring in cell hall D and farm colony; repair and resurface road and parking areas; insulate new root cellar; roof repairs 89,000

## Subd. 4. At State Training School for Boys:

(1) General repairs and remodeling, including equipment; roof repairs to administration, chapel, and industrial buildings 50,631

## Subd. 5. At Minnesota Home School for Girls:

(1) Natural gas conversion 25,000

(2) Remodel Morse Hall for administrative and clinical offices 15,000

Item (2) shall be expended only after consultation with the *Legislative Building Commission*.

The appropriation made in Extra Session Laws 1961, Chapter 72, Section 2, Subdivision 20 (2) shall not be expended for constructing a superintendent's residence and such appropriation is cancelled.

## Subd. 6. At Willow River Youth Forestry Camp:

(1) Relocate gas line; sewer repairs; ventilate and paint gymnasium; partition and equip craft activities area; water softener and iron filter; replace doors in kitchen and related corrective repairs 12,000

## Subd. 7. At Rochester Youth Vocational Center:

(1) Prepare preliminary plans and specifications and site selection for a new facility 40,000

Out of the unexpended balances of the moneys appropriated by Laws 1961, Chapter 72, Section 2, Subdivision 7 (3) for remodeling Cell Block area A5-B5 to supplement 1957 appropriation for plumbing and heating in asylum for dangerous insane — \$34,280.00; and item (7) for repair of fire stairs and remodeling of front entrance and area way of administration building including reception area remodeling — \$80,000.00, are hereby reappropriated to the commissioner of administration for remodeling the first floor of the administration building for medical offices and to remodel present psychopathic building into an administration office at the St. Peter State Hospital.

Subd. 5. The commissioner of administration shall contract with the city of Bemidji to improve the sanitary sewer and water distribution system at Bemidji State College. The total cost of such improvement is hereby appropriated in an amount not to exceed \$55,000.00.

The appropriation made by this subdivision shall be from the building outlay account in the state treasury.

Sec. 6. Notwithstanding any provision of law to the contrary, all the moneys appropriated herein shall be deemed for construction or other building improvement and shall be available until the purpose for which the appropriation was made shall have been accomplished or abandoned.

Sec. 7. This act is effective July 1, 1965.

CHAPTER 830—S. F. No. 2081

*An act relating to the powers of the executive council in the case of state emergencies; appropriating money therefor; amending Minnesota Statutes 1961, Section 9.061, Subdivision 5; repealing Minnesota Statutes 1961, Section 9.061, Subdivisions 6, 7, 8, 9, and 10.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1961, Section 9.061, Subdivision 5, is amended to read:

Subd. 5. **Executive council; state emergencies.** Where an emergency exists the executive council may; ~~within the amount appropriated to the executive council for the purposes of this section; expend such amount as is necessary~~ *expend such sums of money as are necessary therefor, but not to exceed \$2,000,000 in any one fiscal year, and such sums of money are hereby appropriated annually from the general revenue fund in the state treasury for such purpose. For the purpose of supplying any deficiency that may arise in the general revenue fund by reason of the appropriation made by this subdivision, the treasurer may temporarily borrow from other public funds a sum not exceeding \$2,000,000 in addition to any other temporary borrowing otherwise authorized by law in any year; provided, that no funds shall be so impaired thereby that all proper demands thereon cannot be met.*
