customary conduct and operation of his business, in which he has been licensed under this section to engage. Motor vehicles, new or used, owned by such motor vehicle dealer and bearing such number plates, may be driven upon the streets and highways for demonstration purposes by any prospective buyer thereof for a period of 48 hours. Any meter truck, truck-tractor or semi-trailer, new or used, owned by such motor vehicle dealer and bearing the motor vehicle dealer's number plates may be driven used upon the streets and highways of this state, for demonstration purposes by any prospective buyer for a period of seven days.

A new motor vehicle sold by such motor vehicle dealer and bearing the motor vehicle dealer's number plates may be driven upon the public streets and highways for a period of 72 hours by the buyer for the purpose of either of the following purposes: (1) Removing the vehicle from this state for registration in another state: , or (2) permitting the buyer to use the motor vehicle before he receives number plates pursuant to his own registration. Use of a new motor vehicle by the buyer under the provisions of clause (2) of the preceding sentence before he receives number plates pursuant to his own registration constitutes a use of the public streets or highways for the purpose of the time requirements for registration of motor vehicles. Upon the delivery of such new motor vehicle to the buyer or upon the delivery of such motor vehicle or motor truck, truck-tractor or semi-trailer, new or used, to the prospective buyer for demonstration purposes, the motor vehicle dealer shall deliver to the buyer or prospective buyer, as the case may be, a card or certificate giving the name and address of the motor vehicle dealer, the name and address of such buyer or prospective buyer, and the date and hour of such delivery. Such card or certificate shall be in such form as the registrar may provide to the motor vehicle dealer for such purpose, and shall be carried by such buyer or prospective buyer while driving the motor vehicle or motor, truck- or trucktractor.

An act authorizing the renewal of the period of corporate existence of certain cemetery corporations, whose period of duration

has expired without the renewal thereof, and legalizing acts and contracts of such corporations made or done and performed subsequent to the expiration of said corporation.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Cemetery corporations; corporate existence, renewal. Any cemetery corporation heretofore organized under the laws of this state, having unissued capitol stock, whose period of duration expired on or prior to January 16, 1952 and the same has not been renewed and such corporation has continued or continues to transact its business, or whose assets have not been liquidated and distributed, may, reorganize as now provided in Minnesota Statutes 1961, Sections 306.58 to 306.62, or Section 306.68, and renew its corporate existence from date of its expiration to further definite term or perpetually from and after its expired period of duration with the same force and effect as if renewed prior to the expiration of its existence.
- Sec. 2. Limitation of time. Such proceedings to obtain such extension shall be taken within two years after the approval of this act.
- Sec. 3. **Proceedings to relate back.** When such proceedings are taken within such period of time, such proceedings shall relate back to the date of the expiration of such original corporate period, as fixed by its articles of incorporation or by statutory limitation, and when such period is extended as provided by this act, any and all corporate acts and contracts done and performed, made and entered into after the expiration of said original period, shall be and each is hereby declared to be legal and valid.
- Sec. 4. **Application.** This act shall not apply to any corporation, the charter of which has been declared forfeited by the final judgment of any court of competent jurisdiction of this state or to any corporation as to which there is pending action or proceedings in any of the courts of this state, for the forfeiture of its charter, nor shall this act affect any action or proceedings now pending in any of the courts of this state in relation to any corporation described in section 1.
