

Section 1. Minnesota Statutes 1965, Section 35.50, is amended to read:

35.50 **Hog cholera vaccines.** *After June 30, 1959,* The sale or use of virulent blood or virulent live hog cholera virus for the prevention of hog cholera is prohibited. *After January 1, 1968,* the sale or use of modified live hog cholera virus vaccine for the prevention of hog cholera is prohibited, except that the board ~~shall~~ *may* permit the sale and use of such products whenever necessary either to protect the health of domestic animals or to qualify animals for export to other states or foreign countries.

Sec. 2. Minnesota Statutes 1965, Section 35.51, is amended to read:

35.51 **Permits to administer modified live hog cholera virus vaccine.** No person shall use or administer any product containing living hog cholera virus within this state unless he shall have been granted a permit by the board authorizing him to use or administer the same. Permits for the use or administration of ~~virulent blood or virulent hog cholera virus~~ *modified live hog cholera virus vaccine* shall be in writing and shall be issued only to licensed veterinarians.

Sec. 3. **Repealer.** *Minnesota Statutes 1965, Sections 35.52 and 35.53, are repealed.*

Sec. 4. **Effective date.** *This act is effective January 1, 1968.*

CHAPTER 167— S. F. No. 767

An act relating to highways, authorizing the commissioner of highways to prepare detailed plans of buildings and facilities for rest areas, tourist information centers, and weigh stations.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [160.28] **Highways; plans for rest areas, tourist information centers and weigh stations.** The provisions of any other law to the contrary notwithstanding, the commissioner of highways is hereby authorized to cause to be prepared plans and specifications and detailed designs for the construction of buildings and facilities for rest areas, tourist information centers in combination with

rest areas, and weigh stations when he deems such buildings and facilities to be necessary in the interest of safety and convenient public travel on highways.

CHAPTER 168—S. F. No. 793

An act authorizing the conveyance of certain real estate owned by the state to the city of Virginia; amending Laws 1961, Chapter 167, Sections 1 and 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1961, Chapter 167, Section 1, is amended to read:

Section 1. State land, conveyance to city of Virginia. Notwithstanding any law to the contrary, the governor, upon the recommendation of the commissioner of highways, shall transfer and convey by proper deed of conveyance in the name of and on behalf of the state of Minnesota, to the city of Virginia, a municipal corporation, in the county of St. Louis; ~~for public purposes,~~ all or any portion of the following described real estate situated in St. Louis county, Minnesota, to-wit:

The south 333.0 feet of the southeast quarter of the southwest quarter (SE 1/4 SW 1/4) of section 6, township 58 north, range 17 west, excepting therefrom the east 250 feet, the west 450 feet and the south 83 feet thereof, containing 3.41 acres, more or less. Together with the west 100 feet of the east 250 feet of the north 300 feet of the south 333 feet of the southeast quarter of the southwest quarter (SE 1/4 SW 1/4) of section 6, township 58 north, range 17 west, containing 0.69 acre, more or less.

The north 250 feet of the south 333 feet of the southeast quarter of the southwest quarter (SE-1/4 SW-1/4) of Section 6, township 58 north, range 17 west, excepting therefrom the east 150 feet and the west 450 feet; containing 3.98 acres, more or less.
