CHAPTER 715—S. F. No. 371

An act relating to the teachers retirement association; supplemental pensions, and appropriating money; amending Minnesota Statutes 1965, Section 354.55, by adding a subdivision.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1965, Section 354.55, is amended by adding a subdivision to read:

Subd. 6. Teachers retirement; supplemental pensions. Each annuitant who as a member of the fund commenced drawing his annuity between August 1, 1931, and June 30, 1965, but not including his beneficiaries, shall be paid ten percent of his present monthly annuity if such annuitant retired pursuant to Minnesota Statutes 1965, Sections 354.33 and 354.34 and fifteen percent of his present monthly annuity if such annuitant retired pursuant to Minnesota Statutes 1953, Section 135.10 and Minnesota Statutes 1965, Sections 354.44 and 354.45, in addition to the amounts such annuitant is otherwise entitled to receive under the provisions of Sections 354.05 to 354.14, and 354.31 to 354.55 and Sections 354.58 and 354.59.

The supplemental benefit provided for in this subdivision is not a vested right, and the legislature reserves the power to withdraw, abolish, or modify it in any way, and this benefit shall be paid from the general revenue fund and such moneys as are required for its payment are hereby annually appropriated to the teachers retirement fund.

Sec. 2. This act takes effect July 1, 1967.

An act relating to compensation of members of county boards in certain counties; amending Minnesota Statutes 1965, Sections 375.055, Subdivisions 1, 4 and 5, and 375.06, Subdivision 1; repeal-

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1965, Section 375.055, Subdivision 1, is amended to read:

375.055 County boards; members' compensation. Subdivision 1. **Fixed by county board.** The county commissioners in all counties of the state having a population of less than 100,000 according to the 1960 federal census, shall receive as compensation for services rendered by them for their respective counties, annual salaries, in an amount set by the county board, *provided that such salary shall not become effective until January 1 of the next odd numbered calendar year, and provided that such salary is established in conformity with this subdivision. The county board may establish a new salary by a resolution adopted and published in the even numbered year not less than 30 days prior to the date of opening of filings for the office of county commissioner. The resolution shall contain a statement of the new salary to be established set forth on an annual basis. In addition to its publication in the official newspaper of the county as part of the proceedings of the meeting of the county board, the same shall be published in one other newspaper of the county, if there be one located in a different municipality in the county than the official newspaper. The salary of a county commissioner shall not change except in accordance with the provisions of this subdivision. not to exceed the amounts hereinafter provided based upon the population according to the then last proceeding state or federal census; the taxable valuation of real and personal property, exclusive of money and credits; as reported in the abstract of tax lists for the preceding year; and the number of full or fractional congressional townships; as follows:*

(a)—In counties with less than 6,500 inhabitants \$400 and \$300 for each \$1,000,000 taxable valuation or major fraction thereof; and \$3 for each full or fractional congressional township; with the aggregate not to exceed \$900;

(b)—In counties with 6,500 but less than 12,000 inhabitants \$400 and \$175 for each \$1,000,000 taxable valuation or major fraction thereof; and \$3 for each full or fractional congressional township; with the aggregate not to exceed \$1,050;

(c)—In counties with 12,000 but less than 16,000 inhabitants \$500 and \$100 for each \$1,000,000 taxable valuation or major fraction thereof; and \$3 for each full or fractional congressional township; with the aggregate not to exceed \$1,250;

(d)—In counties with 16,000 but less than 21,000 inhabitants \$600 and \$65 for each \$1,000,000 taxable valuation or major fraction thereof, and \$3 for each full or fractional congressional township, with the aggregate not to exceed \$1,350;

(e)—In counties with 21,000 but less than 30,000 inhabitants, \$850 and \$40 for each \$1,000,000 taxable valuation or major fraction thereof, and \$3 for each full or fractional congressional township, with the aggregate not to exceed \$1,420;

(f)—In counties with 30,000 but less than 50,000 inhabitants, \$1,050 and \$35 for each 1,000,000 taxable valuation or major fraction thereof, and \$3 for each full or fractional congressional township, with the aggregate not to exceed \$1,750;

(g)—In counties with 50,000 but less than 100,000 inhabitants, \$1,250 and \$25 for each \$1,000,000 taxable valuation or major fraction thereof, and \$2 for each full or fractional congressional township, with the aggregate not to exceed \$1,800.

Sec. 2. Minnesota Statutes 1965, Section 375.055, Subdivision 4, is amended to read:

Subd. 4. **Inconsistent provisions superseded.** Except as otherwise herein provided, all acts or parts of acts, which relate to salaries of county commissioners, in any county of the state having a population of less than 100,000 according to the last 1960 federal census, are hereby ~~repealed~~ *superseded as of January 1, 1969* insofar as they are inconsistent with the provisions of this section.

Sec. 3. Minnesota Statutes 1965, Section 375.055, Subdivision 5, is amended to read:

Subd. 5. **Other benefits.** *Except as provided herein nothing* ~~Nothing~~ in this section shall limit the right of a county commissioner to collect and retain any fees, per diem payment, or any mileage or expense allowance, payment in lieu of mileage or reimbursement of expenses in attending meetings or in the conduct of the business of a board, commission or committee of county government on which he serves, ~~other payment~~ which he is now authorized by any other provision of the law to collect and retain in addition to the stated amount of his annual salary; or to participate in any group insurance program instituted by the county board for county officers and employees; *provided that the several members of the county board shall not receive a per diem for service on the Board of Auditors, the Board of Equalization, or the Canvassing Board and provided further that a county commissioner shall not be paid in excess of \$50 by way of per diems for service in any calendar month on a committee of the*

county board or on any board, commission or committee of county government or a total of \$400 for such service in any calendar year.

Sec. 4. Minnesota Statutes 1965, Section 375.06, Subdivision 1, is amended to read:

375.06 Compensation for committee work; travel expenses.
Subdivision 1. The several members of the county boards in counties having less than ~~75,000~~ 100,000 inhabitants according to the 1960 federal census shall receive \$10 per day for each and every day necessarily occupied in the discharge of their official duties while acting on any committee under the direction of the board, and may be allowed and paid in addition thereto their actual and necessary traveling expenses incurred in the discharge of such committee work. Any committee may be comprised of all of the members of the county board.

The several members of the county boards in addition to any compensation authorized for their duties may be allowed and paid their actual and necessary traveling expenses in attending meetings of the board. The chairman of the county board shall receive seven and one half cents per mile, each way, for going to the county seat to sign warrants during recess of the county board.

Sec. 5. Minnesota Statutes 1965, Sections 375.05 and 375.055, Subdivisions 2 and 7 are repealed.

Sec. 6. *This act is in effect on January 1, 1969, except that a resolution may be adopted and published pursuant to and in accordance with the provisions of section 1 during the year 1968, and that any county commissioner's salary established by or pursuant to general or special law on or before December 31, 1968, and in effect on that date shall thereafter remain in effect until changed in accordance with the provisions of this act.*
