Commencing at the southeast corner of the southwest quarter of southeast quarter of section 31, township 39, range 21, thence north over and along the east boundary line of the said southwest quarter of southeast quarter to the northeast corner of the said southwest quarter of southeast quarter; thence west over and along the north boundary line of the said southwest quarter of southeast quarter to the east edge of the following described tract:

All that part of government lot 4 and of the southwest quarter of southeast quarter of section 31, town 39 north, range 21 west, Pine county, Minnesota, described jointly as follows: Commencing at the south quarter corner of said section 31; thence on an assumed bearing of north (0°00') along the north-south quarter line of said section 31, a distance of 1167.0 feet to the point of beginning; thence south 57°00' east a distance of 170.0 feet; thence north 33°00' east a distance of 492.0 feet; thence north 57°00' west a distance of 489.5 feet to said north-south quarter line of section 31; thence south along said north south quarter line a distance of 586.65 feet to the point of beginning, containing 3.73 acres, more or less,

- Sec. 2. St. Paul, city of; employees' retirement. Funds appropriated by the city of Saint Paul pursuant to the provisions of Laws 1963, Chapter 851, Section 2, as amended by Laws 1965, Chapter 783, Section 2, for payment of insurance benefits for retired officers and retired employees of said city may be used by said city in payment of an insurance benefit program for retired city officers and retired city employees established pursuant to the provisions of Minnesota Statutes 1965, Section 471.61.
- Sec. 3. This act shall become effective only after its approval by a majority of the governing body of the city of Saint Paul and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

- 207.19 Elections; absentee ballots; residence affidavit; registration; request; ballot. Subdivision 1. Registration for the primary and general elections may be made by or for any member of the armed forces over 21 years of age or who will attain the age of 21 years on or before the date of the next primary or general election occurring after such registration by the member of the armed forces himself or by a parent, spouse, or a brother, sister, or child over the age of eighteen years, by filing in the office of the county auditor of the county of which he was a resident prior to his entrance into the armed forces in which his place of residence is located, a request for ballot in substantially the following form, whether said request for ballot is upon a form prepared and distributed by the war and navy departments or otherwise:
