CHAPTER 197—H. F. No. 782

[Coded]

*An act relating to counties; authorizing the creation and maintenance of sheriffs' contingent funds.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [387.212] **Sheriffs; contingent fund.** The board of county commissioners in any county may create a sheriff's contingent fund and may credit thereto not more than \$1,000. The moneys in such fund may be used for the advancement and reimbursement of expenses of the sheriff and his office. Such moneys shall be disbursed by the county treasurer in accordance with rules and regulations prescribed by the board.

CHAPTER 198—H. F. No. 1300

*An act relating to the city of Winona; providing for the appointment of the city treasurer by the city council.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Winona, city of; treasurer; appointment.** Notwithstanding the provisions of any other law to the contrary, the treasurer of the city of Winona shall be appointed by the city council by vote of a majority of all of its members on the third Monday of April in each year for a term of one year commencing May 1, provided that the person who is treasurer on the date this act becomes effective shall continue in office for the remainder of the term to which he was elected or appointed and until his successor is appointed and qualifies, subject to any power of removal vested in the city council by other law.

Sec. 2. **Effective date.** This act shall become effective upon its approval by the governing body of the city of Winona and upon compliance with Minnesota Statutes 1965, Section 645.021.

CHAPTER 199—H. F. No. 1448

*An act relating to tax levies for library purposes in the village of Mountain Iron.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Mountain Iron, village of; library tax levy.** In addition to the levy for library purposes authorized by Minnesota Statutes, Sections 412.251 and 134.07, the village council of the village of Mountain Iron may levy in 1967 only, a number of mills sufficient to produce \$5,000, which additional amount shall be used for capital improvements to the village library. Such additional levy shall not be made unless approved by a majority of the electors voting on the question at a special village election.

Sec. 2. This act shall be effective upon its approval by a majority of the members of the village council of the village of Mountain Iron, and upon compliance with Minnesota Statutes 1965, Section 645.021.
