365.51 **Towns; elections; precincts; polling places.** There shall be an annual town meeting held in each town on the second Tuesday of March at the place of holding the last town meeting, or at such other place in the town, or in the city or village within or adjoining the same, designated by the annual town meeting. The clerk shall give ten days' published notice in a qualified newspaper having general circulation within the town or by posted notice, or both, as the voters at the annual town meeting may direct, specifying the time and place, but if the town meeting shall fail to direct the manner of
