(a) *In a completed building, if the installation conforms in every respect to the local building codes; if the installation uses fresh air taken entirely from outside the building; and if the carbon monoxide content of the room's atmosphere does not exceed fifty parts to one million parts of air at any time.*

(b) *In the erection or remodeling of buildings, if the carbon monoxide content of the room's atmosphere does not exceed fifty parts to one million parts of air at any time.*

#### CHAPTER 388—S. F. No. 1067

*An act relating to county officers; authorizing county boards to provide additional compensation to county officers who are assigned additional duties; amending Minnesota Statutes 1965, Sections 384.151, Subdivisions 1 and 5; 385.373, Subdivisions 1 and 5; 386.015, Subdivision 2; and 485.018, Subdivisions 2 and 5.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1965, Section 384.151, Subdivision 1, is amended to read:

**384.151 Counties; officers; fees; county auditors' salaries, fees and clerk hire, counties under 75,000 inhabitants; appeals.** Subdivision 1. **Salary schedule.** The county auditors in all counties of the state with less than 75,000 inhabitants according to the 1960 federal census, shall receive as full compensation for services rendered by them for their respective counties, annual salaries, not less than the following amounts based on the population according to the then last preceding federal census:

- (a) In counties with less than 10,000 inhabitants \$6,000;
- (b) In counties with 10,000 but less than 20,000 inhabitants \$6,500;
- (c) In counties with 20,000 but less than 30,000 inhabitants \$7,000;

(d) In counties with 30,000 but less than 40,000 inhabitants \$7,500;

(e) In counties with 40,000 or more inhabitants \$8,000;

(f) The county board of each of the counties specified in this subdivision annually shall set by resolution the salary of the county auditor which shall be paid to the county auditor at such intervals as the board shall determine but not less often than once each month. At the January meeting prior to the first date on which applicants may file for the office of county auditor the board shall set by resolution the minimum salary to be paid the county auditor for the term next following. In the event a vacancy occurs in the office of county auditor the board may set the annual salary for the remainder of the calendar year at an amount less than was set for that year. The board, in any case specified in this subdivision, may not set the annual salary at an amount less than the minimums provided in this subdivision but it may set the salary in excess of such minimums. The salary of the county auditor shall not be reduced during the term for which he was elected or appointed.

*In the event that duties are assigned to the auditor which are in addition to his duties as auditor, additional compensation may be provided for the additional duties. The county board by resolution shall determine the additional compensation which shall be paid and specify the duties for which the additional compensation is to be paid.*

Sec. 2. Minnesota Statutes 1965, Section 384.151, Subdivision 5, is amended to read:

Subd. 5. **Collection of fees.** The county auditor shall charge and collect all fees as prescribed by law and all such fees collected by him shall be paid to the county in the manner and at the times prescribed by the county board, but not less often than once each month. The county auditor shall not retain any additional compensation, per diem or other emolument for his services ~~in any activity of county government as county auditor~~, but may receive and retain mileage and expense allowances as prescribed by law.

Subd. 5. **Collection of fees.** The county treasurer shall charge and collect all fees as prescribed by law and all such fees collected by him shall be paid to the county in the manner and at the times prescribed by the county board, but not less often than once each month. In the event a vacancy occurs in the office of the register of deeds the board may set the annual salary for the remainder of the calendar year at an amount less than was set for that year. The board in any case specified in this subdivision may not set the annual salary at an amount less than the minimum provided in subdivision 1 but it may set the salary in excess of such minimums. The salary of the register of deeds shall not be reduced during the term for which he is elected or appointed.

*In the event that duties are assigned to the register of deeds which are in addition to his duties as register of deeds, additional compensation may be provided for the additional duties. The county board by resolution shall determine the additional compensation which shall be paid and specify the duties for which the additional compensation is to be paid.*

Sec. 6. Minnesota Statutes 1965, Section 485.018, Subdivision 2, is amended to read:

Subd. 2. **Set by board.** The county board of each of the counties specified in subdivision 1 annually shall set by resolution the salary of the clerk of district court which shall be paid to the clerk of district court at such intervals as the board shall determine but not less often than once each month. At the January meeting prior to the first date on which applicants may file for the office of clerk of district court the board shall set by resolution the minimum salary to be paid the clerk of district court for the term next following. In the event a vacancy occurs in the office of the clerk of district court the board may set the annual salary for the remainder of the calendar year at an amount less than was set for that year. The board in any case specified in this subdivision may not set the annual salary at an amount less than the minimums provided in subdivision 1 but it may set the salary in excess of such minimums. The salary of the clerk of district court shall not be reduced during the term for which he is elected or appointed.

The clerk of district court shall not retain any additional compensation, per diem or other emolument for his services in any activity of county government as clerk of district court, but may receive and retain mileage and expense allowances as prescribed by law.

#### CHAPTER 389—S. F. No. 1398

*An act relating to parking privileges for the physically handicapped; amending Minnesota Statutes 1965, Section 169.345, Subdivision 2, and repealing Minnesota Statutes 1965, Section 169.345, Subdivision 5.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1965, Section 169.345, Subdivision 2, is amended to read:

Subd. 2. **Handicapped; parking privileges; definition of physically handicapped.** Physically handicapped as employed herein shall include any person who has sustained an amputation or permanent material disability of either or both arms or legs, or who has been otherwise permanently disabled in any manner rendering it difficult and burdensome for him to walk.

Sec. 2. *Minnesota Statutes 1965, Section 169.345, Subdivision 5, is repealed.*
