(5) Every person employed hereunder shall be subject to the terms and provisions of Laws 1935, Chapter 254, and acts amendatory thereof.

(6) The commissioner is authorized to employ and designate a highway safety director, who shall supervise and coordinate the activities of the Minnesota highway patrol and the drivers license division and perform such other duties as the commissioner may prescribe. He shall have all the powers, duties and rights of a highway patrol member. His salary shall be \$1,079 per month.

CHAPTER 420-H. F. No. 584

An act relating to Independent School District No. 833, authorizing it to issue bonds.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Independent School District No. 833; bonds. Notwithstanding the limitations of Minnesota Statutes, Section 475.53, Independent School District No. 833, which includes the villages of St. Paul Park and Newport and other territory, may issue general obligation bonds of the district in an amount not exceeding \$6,000,000 over and above indebtedness heretofore incurred by it. Such bonds shall be authorized by vote of the people, and shall be sold and issued at such time or times as may be determined by the school board, in the manner prescribed by Minnesota Statutes, Chapter 475; provided, that if prior to issuing any of such bonds the district obtains any capital loan or loans under the maximum effort school aid law, the amount of bonds authorized hereby shall be reduced by the amount of such loan or loans.

Sec. 2. The district may sell and issue bonds hereunder without having to comply with Minnesota Statutes, Section 124.43, Subdivision 6, as to paying or refunding any outstanding capital loan heretofore or hereafter created.

Sec. 3. The district may levy the taxes required by law for the payment of such bonds and interest thereon without limitation as to rate or amount, and the levy of such taxes shall not cause the amount of other taxes, levied or to be levied by the district, which

are subject to any such limitation, to be reduced in any amount whatsoever.

Sec. 4. This act shall be effective upon its approval by the school board of Independent School District No. 833 and upon compliance with Minnesota Statutes, Section 645.021.

An act adding a new route to the trunk highway system.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. [161.115] Trunk highways; new route; Route No. 327. There is hereby added a new route to the trunk highway system as follows: Beginning at a point on route 392 near Plymouth Avenue in the city of Minneapolis; thence extending in a general easterly direction to a point on route 394 in the city of Minneapolis.

Sec. 2. The revisor of statutes is directed to assign a number to such route and compile the same in the Minnesota Statutes.
