

## CHAPTER 496—S. F. No. 1373

*An act relating to recreational programs and facilities; amending Minnesota Statutes 1965, Section 471.16.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1965, Section 471.16, is amended to read:

471.16 **School districts; recreation program.** Any city, however organized, or any village, borough, town, county, school district, or any board thereof, or any incorporated post of the American Legion or any other incorporated veterans' organization, may operate such a program independently, or they may cooperate in its conduct and in any manner in which they may mutually agree; or they may delegate the operation of the program to a recreation board created by one or more of them, and appropriate money voted for this purpose to such board. ~~In the case of school districts the right to enter into such agreements with any other public corporation, board, or body, or the right to delegate power to a board for operating a program of recreation, shall be authorized only by a majority vote cast at an annual school election.~~

## CHAPTER 497—S. F. No. 1382

*An act relating to courts, and salaries of the Ramsey county district court reporters, second judicial district.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **District court; Ramsey county court reporters; salary.** Subdivision 1. The chief judge of the district court for the second judicial district, by an order filed with the Ramsey county auditor, shall fix and establish the salary of the Ramsey county second judicial district court reporters at an amount not exceeding \$10,800 per year, exclusive of insurance benefits and severance pay. The salary shall be paid in biweekly installments in the same manner as other county employees are paid. Such order may provide for severance pay for district court reporters on the same general basis as it is provided for other Ramsey county employees. The order

shall be filed within thirty days of the effective date of this act and shall provide for an effective date of the salary schedule.

Subd. 2. All laws now in force relating to the salary of the court reporters of the second judicial district, inconsistent herewith, are hereby repealed and superseded.

CHAPTER 498—S. F. No. 1567

*An act relating to Kandiyohi county; and the assessment of ditch benefits against a vacated town road in the town of St. Johns.*

Be it enacted by the Legislature of the State of Minnesota:

**Section 1. Kandiyohi county; ditch assessment.** When a town road has been vacated in the town of St. Johns in Kandiyohi county during the year 1934, which road previous to the vacation thereof had been assessed ditch benefits, which benefits were paid, the county board of Kandiyohi county shall no longer make any assessment for benefits for costs of repairs or other work in connection with the ditch or drainage system against the vacated road.

Sec. 2. This act takes effect when approved by the county board of Kandiyohi county, and upon compliance with Minnesota Statutes, Section 645.021.
