

CHAPTER 502—S. F. No. 2258

An act relating to the exchange by the state of certain easements for road purposes in lands located in Le Sueur county.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Conveyance of state lands; Le Sueur county. The commissioner of conservation may convey, in the name of the state of Minnesota, upon such terms and conditions as agreed upon to Mike B. Benzick and Mary M. Benzick, the rights and interest of the state in that certain easement for road purposes in LeSueur county acquired by the state from said parties by deed dated August 11, 1958 recorded August 14, 1958 in Book 120 of Deeds page 81 in the office of the register of deeds of LeSueur county.

Sec. 2. The conveyance authorized under section 1 shall be made upon conveyance to the state by Mike B. Benzick and Mary M. Benzick, of an easement for road purposes over lands owned by them, such easement and the description thereof to be as the commissioner determines necessary. The form of the deed of easement to the state shall be approved by the attorney general and the conveyance accepted upon approval by the attorney general of the title to the lands so conveyed. Furthermore, the conveyance by the state under section 1 shall be made only upon approval by the commissioner of the construction of a roadway by Mike B. Benzick and Mary M. Benzick on the lands conveyed in the deed of easement referred to in this section.

An act authorizing the conveyance of certain state lands in Nicollet county to Independent School District No. 508.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Conveyance of state lands; Independent School District No. 508. The governor, upon the recommendation of the commissioners of administration and public welfare, shall transfer and convey by quitclaim deed, in the form the attorney general ap-

proves, in the name of the state of Minnesota, to Independent School District No. 508, of St. Peter, Minnesota, for such consideration and upon such terms and conditions as may be agreed upon, the following described lands in Nicollet county:

All that part of the Northeast Quarter of the Southeast Quarter of Section 20, Township 110 North, Range 26 West described as follows:

Commencing at the Northwest corner of the Southeast Quarter of said Section, thence North 89°-49' East along the North line of the Southeast Quarter 1309.6 feet, thence South 0°-06' East along the West line of the Northeast Quarter of the Southeast Quarter 453.1 feet to a point on the westerly extension of the southerly line of Valley View Addition, St. Peter, Minnesota, the point of beginning; thence South 89°-36' East and along the southerly line of said Valley View Addition 571.3 feet to the Southeast corner of Lot one (1) of said Valley View Addition; thence South 41°-01' East 530.3 feet to the Southwest corner of Lot Nine (9) Carter's Subdivision, St. Peter, Minnesota, thence South 42°-50' East along the Southerly line of said Carter's Subdivision, 318.4 feet to the Westerly right-of-way line of the old Chicago and North Western Railway Company; thence South 22°-53' West along the westerly right-of-way line of said railroad 241.4 feet to the south line of said Northeast Quarter; thence South 89°-51' West along the south line of said Northeast Quarter 1039.4 feet to the Southwest corner of said Northeast Quarter; thence North 0°-0.6' West along the West line of said Northeast Quarter 862.7 feet to the point of beginning; containing 18 acres of land more or less.
