

## CHAPTER 675—H. F. No. 2308

*An act relating to Carver county; relating to land acquisition for parks therein in certain cases; amending Laws 1967, Chapter 131, Section 2.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1967, Chapter 131, Section 2, is amended to read:

Sec. 2. **Carver county; park lands.** ~~This act~~ *Laws 1967, Chapter 131*, shall not apply to the acquisition for park purposes of lands by the state of Minnesota, the county of Carver, or any city, village, ~~or~~ *or* borough, *or town* situated within the county of Carver, nor shall ~~this act~~ *Laws 1967, Chapter 131*, apply to the transfer of real estate between public agencies listed in *Laws 1967, Chapter 131*, Section 1.

Sec. 3. *This act shall become effective only after its approval by the governing body of the county of Carver, and upon compliance with the provisions of Minnesota Statutes, Section 645.021.*

CHAPTER 676—S. F. No. 2190

*An act relating to the district court in Olmsted county; providing for the selection and drawing of jurors.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Olmsted county; district court; jurors.** Notwithstanding the provisions of Minnesota Statutes, Section 593.03, not less than 48 petit jurors shall be drawn for each general term of the district court for Olmsted county; but in his discretion the judge of district court for said county, by order filed with the clerk at least 30 days before any term, may direct that a greater number be drawn, not exceeding 90 in all, or that no petit jury be drawn for such term.

Sec. 2. Notwithstanding the provisions of Minnesota Statutes, Section 593.13, the county board of Olmsted county, at its annual session in January, shall select from the qualified voters of the county

288 rather than 144 persons to serve as petit jurors in the district court for Olmsted county. In all other respects the provisions of section 593.13 shall apply to Olmsted county.

Sec. 3. This act shall take effect upon its approval by the governing body of Olmsted county and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

#### CHAPTER 677—H. F. No. 1102

*An act relating to Independent School District No. 719; authorizing its school board to establish a deferred compensation plan for employees.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Independent School District No. 719, Prior Lake; deferred compensation.** The school board of Independent School District No. 719, which includes within its boundaries the village of Prior Lake, is hereby authorized to establish, amend or terminate a qualified deferred compensation plan for some or all of its employees under sections 401, 402, and 501 of the current federal internal revenue code or any equivalent provision of subsequent federal income tax law. The plan shall be administered by a trust company authorized to do business in this state. Contributions shall be limited to \$200 per participating employee per year. The establishment of such a plan shall not affect the rights and liabilities of the board and teachers of the district under Minnesota Statutes, Section 125.12.

Sec. 2. This act shall become effective upon approval by the members of the school board of said district and upon compliance with Minnesota Statutes, Section 645.021.
