

Section 1. Laws 1965, Chapter 541, Section 1, is amended to read:

Section 1. **Stearns county; commissioners' salaries and expenses.** *Notwithstanding the provisions of any general law enacted prior hereto, whether effective before or after this act, the annual salaries of each of the members of the board of county commissioners of Stearns county shall be set by said board at a sum not to exceed \$3,600, which sum shall be payable in equal monthly installments. Each member of the board of county commissioners shall be allowed a sum not to exceed \$900 per year, which said sum shall be payable in equal monthly installments as and for expense account reimbursed at the rate specified in Minnesota Statutes, Section 15A.20, for the use of his private automobile in performance of official county duties, including but not limited to his duties as a county commissioner and as a member of any board, commission, or committee. Reimbursement for mileage shall be paid on warrant of the county auditor after approval by the county board of an itemized and verified bill submitted by a county commissioner.*

Sec. 2. *This act is effective upon its approval by the members of the county board of Stearns county and upon compliance with Minnesota Statutes, Section 645.021.*

An act relating to the probate court of St. Louis county; fixing the salary of the judge, referee and clerk thereof; amending Laws 1965, Chapter 570, Sections 1 and 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1965, Chapter 570, Section 1, is amended to read:

Section 1. **St. Louis county; probate court; salary.** The annual salary of the judge of probate court of St. Louis county is ~~\$17,000~~ *\$18,500*, notwithstanding the provisions of ~~Laws 1961, Chapter 610, Section 1~~ *any law to the contrary.*

Sec. 2. Laws 1965, Chapter 570, Section 2, is amended to read:

Sec. 2. Probate court of St. Louis county; salary of referee and clerk.. The annual salary of the referee in probate court of St. Louis county is ~~\$2,500~~ *\$3,750* and the annual salary of the clerk of probate court of St. Louis county is ~~\$10,000~~ *\$11,000*, notwithstanding the provisions of ~~Laws 1955, Chapter 747, Section 2, as amended by Extra Session Laws 1959, Chapter 3, Section 2, and Laws 1957, Chapter 616, Section 1, respectively any law to the contrary.~~

CHAPTER 681—H. F. No. 2119

An act relating to the city of Winona; authorizing it to engage in the development of property for industrial and commercial uses.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Winona, city of; property development. The city of Winona is hereby authorized to acquire any improved or unimproved land for interest therein within seven miles of its corporate limits by purchase, gift, or lease and to develop and lease or sell said land whether improved or unimproved for commercial or industrial uses. In the development of the land the city may do whatever is necessary to make it fit for industrial or commercial use, including but not limited to the following:

- (a) platting, replatting, grading, regrading, filling, removing, and relocating such land, and protecting it by dikes and walls;
- (b) furnishing municipal water and sanitary and storm sewer service;
- (c) constructing or improving streets or alleys;
- (d) razing, repairing, remodeling, or rebuilding structures; and
- (e) building and furnishing new buildings or structures.

Nothing herein shall be deemed to confer on the city the power to operate or aid in operating any private business enterprise, except as the lessor of the premises.
