

sota that it hereby petitions the President, Secretary of Agriculture and the Congress of the United States to curb price depressing importation of agricultural commodities and products; and

BE IT FURTHER RESOLVED that the federal government continue to resist price depressing agricultural imports until such time as agricultural prices to the American farmer are in balance and in keeping with the cost of production, and

BE IT FURTHER RESOLVED that the federal government immediately take all necessary steps to provide a return to the dairy producers in sufficient amount to assure a necessary and vital supply for the great needs of this country;

BE IT FURTHER RESOLVED that the Secretary of State of the State of Minnesota, be instructed to forward copies of this resolution to Lyndon Baines Johnson, President of the United States, Secretary of Agriculture, Orville L. Freeman, the Honorable John W. McCormack, Speaker of the United States House of Representatives; the Honorable Mike Mansfield, Majority Leader of the United States Senate; and the members of the Minnesota congressional delegation.

RESOLUTION No. 6—H. F. No. 1226

*A resolution memorializing the President and Congress to abolish residence requirements for all federally supported programs for assistance to the blind.*

WHEREAS the United States has appropriated substantial money to the several states for programs to assist the rehabilitation and aid in the support of the blind; and

WHEREAS the several states have various and inconsistent residence requirements necessary for persons to qualify for assistance to the blind; and

WHEREAS these requirements impede the movement of the blind throughout the union; and

WHEREAS it would be of great value to persons otherwise qualified for assistance and to the public at large that those citizens have the same ease of movement throughout the union that citizens not so disadvantaged possess; now, therefore,

BE IT RESOLVED By the Legislature of the State of Minnesota that Congress should speedily enact legislation to abolish residence requirements for all federally supported programs for aid to the blind.

BE IT FURTHER RESOLVED that the Secretary of State of the State of Minnesota be instructed to transmit copies of this resolution to the President of the United States, the President of the Senate of the United States, the Speaker of the House of Representatives of the United States and to the Minnesota Senators and Representatives in Congress.

RESOLUTION No. 7—H. F. No. 2344

*A resolution memorializing the people and government of Canada on the occasion of their National Centennial, the Pan American Games and Expo '67.*

WHEREAS it is one hundred years since the Union of Canada under its present form of government; and

WHEREAS the People of Minnesota have long cherished their close friendship and easy interchange of ideas and visitors with Canada and especially the Provinces of Manitoba and Ontario; and

WHEREAS the People of Minnesota happily note that the city of Winnipeg has been chosen as the host of the Pan American Games; and

WHEREAS the People of Minnesota enthusiastically hail the celebration of Canada's centennial at Expo '67; and

WHEREAS these events emphasize the great qualities of the People of Canada and will bring a general increase in international understanding; now therefore,

BE IT RESOLVED By the Legislature of the State of Minnesota that the People of Minnesota use the occasion of these events to affirm this longstanding friendship, to acknowledge admiration for the Canadian People and Canadian institutions, and to express their great satisfaction in the success, confidently anticipated, of the Pan American Games and Expo '67.

BE IT FURTHER RESOLVED that the Secretary of State of the State of Minnesota be instructed to transmit copies of this resolution, in English and French, to the Governor-General of Canada,
