Sec. 13. Minnesota Statutes 1967, Section 483.03, is amended to read:

483.03 Report to governor. The judicial council shall make a biennial report on or before ~~October 1~~ *November 15*, in each even numbered year, to the governor *and the legislature*, upon the work of the various branches of the judicial system. It may also, from time to time, submit for the consideration of the several courts and judges, such suggestions in regard to rules of practice and in regard to procedure as it may deem advisable.

Sec. 14. Minnesota Statutes 1967, Section 626.48, is amended to read:

626.48 Reports. Biennially, on or before ~~October 1~~ *November 15*, in each even-numbered year the superintendent shall submit to the governor *and the legislature* a detailed report of the operations of the bureau, of information about crime and the handling of crimes and criminals by state and local officials collected by the bureau, and his interpretations of the information, with his comments and recommendations. In such reports he shall, from time to time, include his recommendations to the legislature for dealing with crime and criminals and information as to conditions and methods in other states in reference thereto, and shall furnish a copy of such report to each member of the legislature.

An act relating to certain organized school districts not maintaining classified schools and situated along the border of Wisconsin; amending Laws 1965, Chapter 739, Section 1, Subdivision 1; repealing Laws 1965, Chapter 739, Section 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1965, Chapter 739, Section 1, Subdivision 1, is amended to read:

Section 1. [122.355] Education; common school districts; continued operation. Subdivision 1. The common school districts situated along the border of the state of Minnesota and the state of Wisconsin which have, for the preceding 25 years, prior to the effective date of this act been educating pupils of their district in school districts in Wisconsin may continue to operate as common school districts after July 1, 1965, notwithstanding that any of such school districts do not maintain classified schools. Such school districts are not subject to the terms and provisions of ~~Laws 1963, Chapter 547 Minnesota Statutes, Sections 122.31 to 122.52.~~

Sec. 2. *Laws 1965, Chapter 739, Section 2, is repealed.*

CHAPTER 542—H. F. No. 2887

An act relating to the village of Lynd; authorizing the village to issue bonds for a fire station and village hall.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Lynd, village of; fire station and village hall. The village of Lynd is authorized to sell and issue \$25,000 of bonds for the purpose of building a fire station and village hall pursuant to Minnesota Statutes, Chapter 475, as authorized by the voters, notwithstanding the limitation on net debt set forth in Minnesota Statutes, Section 475.53, and notwithstanding any failure to publish the notice of election. Such bonds, when issued and delivered for value, shall be valid and binding obligations of the village in accordance with their terms.

Sec. 2. The village council may further secure payment of the bonds by delivering to the purchaser thereof an instrument pledging to the payment of the bonds and interest all collections made by the village of fees for licenses issued pursuant to Minnesota Statutes, Chapter 340, and all distributions made to the village of the taxes on class 2a property pursuant to Minnesota Statutes, Section 273.13.

Sec. 3. This act shall be effective on the day after its final enactment, without approval of the voters.
