vice to all residents of the county when called upon, when the object is to improve the science, art and business of agriculture and home economics and subjects related thereto. The county auditor shall act as secretary of such county extension committee, and keep a record of all its proceedings, and shall forward copies of all resolutions appropriating funds by the county commissioners to the dean of the Institute of Agriculture of the University of Minnesota. The members of the county extension committee shall serve without pay, provided however that they may be reimbursed for expenses or may receive a per diem allowance in accordance with Minnesota Statutes. Section 375.47, except county commissioners who may be entitled to such compensation and paid in like manner as for committee services as county commissioners but subject to the provisions of Section 375.055, Subdivision 5 paid at customary mileago rates for the county for miles necessarily traveled in attending meetings of the committee, and be reimbursed from the general revenue fund of the county for such mileage and other necessary expenses incurred, except members who are also members of the board of county commissioners who may be entitled to such compensation and paid in like manner as for committee services as county commissioners.

An act relating to education; the school census in connection therewith; amending Minnesota Statutes 1967, Chapter 120, by adding a section; and repealing Minnesota Statutes 1967, Sections 120.09 and 144.31.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Chapter 120, is amended by adding a section to read:

[120.095] Education; school census. Subdivision 1. Except as otherwise provided in this section, the school board of each district shall cause to be taken an enumeration, called the school census of all persons under 21 years of age on September 1 during the year the census is taken. The school census shall show the name and date of birth of each person required to be enumerated and the name

and address of his parent, guardian, or other person having charge of such child, and such other data as the state board may require.

Subd. 2. The school census shall be taken by the clerk of the board, or by some other person appointed by the board. Such person taking such census shall certify to the board the correctness of the enumeration and the information therein contained. The board shall fix the compensation for such work. Each child shall be counted in only one district, being that in which he resides as of March 1 in the case of a March 1 through May 1 enumeration period, or September in the case of a September 1 through October 1 enumeration period.

Subd. 3. The school census shall be taken each year during the period March 1 through May 1 or during the period September 1 through October 1 and reported in summary form to the department of education before May 15 of each census year in the case of a March 1 through May 1 enumeration period and before October 15 of each census year in the case of a September 1 through October 1 enumeration period in all districts except as follows:

In districts including cities of the first class and other school districts in which the district boundaries coincide with those of federal census tracts the decennial and middecade census tabulation made by the federal bureau of the census may be substituted for the prescribed enumeration.

Subd. 4. The school board of any district, at its option, may establish a permanent and continuing census or enumeration that will keep current the data required by subdivisions 1 to 3.

Subd. 5. The school census shall include an enumeration of children requiring special education by categories as designated by the state board and as required for reports deemed necessary by the commissioner of education.

Sec. 2. Minnesota Statutes 1967, Sections 120.09 and 144.31, are repealed.
