CHAPTER 1154—H. F. No. 3025

[Coded in Part]

An act relating to the organization and operations of state government; establishing junior colleges and imposing regulations for junior college operations; appropriating moneys with certain conditions for education and related purposes, including the university of Minnesota and its hospitals, state colleges, aids to libraries, junior colleges, higher education coordinating commission, and moneys for medical education; providing aid to school districts including those affected by gross earnings taxation and authorizing the power of eminent domain with certain of the funds provided hereby; transferring moneys between accounts and funds in the state treasury; controlling certain treasury receipts; imposing conditions relative to the expenditure of public moneys, and providing for certain temporary borrowing.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Junior colleges; appropriation.** Except as herein otherwise provided, the sums hereinafter set forth in the columns designated "APPROPRIATIONS", or so much thereof as may be necessary, are hereby appropriated out of the general fund in the state treasury or any other fund herein designated for the purposes specified in the following sections of this act, to be available for the fiscal years indicated for each purpose. The figures "1969", "1970", and "1971" wherever used in this act, shall mean that the appropriation or appropriations listed thereunder shall be available for the year ending June 30, 1969, 1970, and 1971 respectively.

Applications for financial assistance shall contain such information as the department requires including descriptions of areas served by the applicant and the number and distribution of persons residing therein; the local plan of the applicant for promoting library service in the areas it serves and an estimate of the financial assistance to put such plan in effect, and a statement of the ability of local government within the area served by the applicant to finance operations out of public funds raised by local taxes. Financial assistance shall be granted to an eligible applicant proposing an economical and practical plan for the promotion of library service in the area in such amount and subject to such conditions as the department determines after considering the information contained in the application for assistance and the total amount of state and federal funds available for the promotion of library service in the state.

In connection with this appropriation the department shall submit to the United States

commissioner of education a plan for the extension of public library service and the construction of public library facilities pursuant to the Library Services Act, Public Law No. 597, 84th Congress, 2nd Session (June 19, 1956), as amended, and shall adopt rules and regulations for the administration of the plan. Provided that no state funds shall be used for construction of library facilities.

Subd. 8. Inter-Library Cooperation 35,000

Any unexpended balance remaining in the first year shall not cancel but shall be available for the second year of the biennium.

Subd. 9. Professional Teaching Practices Commission 5,000

Any unexpended balance remaining in the first year shall not cancel but shall be available for the second year of the biennium.

Subd. 10. Experimental Laboratory Program 50,000

The laboratory program, known as the Minnesota National Laboratory, may be conducted in cooperation with educational agencies of the several states and the federal government, so that the programs may be applied to schools both within and without the state.

Personnel may be engaged on a contract basis or may be employed from registers in the classified civil service.

The department may accept gifts from public or private sources to finance the Minnesota National Laboratory in whole or in part. Moneys so accepted are appropriated to the department for the purposes for which received.

The program for which this appropriation is made is deemed by the legislature to be experimental and may not be renewed in succeeding years.

Any unexpended balance remaining in the first year shall not cancel but shall be available for the second year of the biennium.

This appropriation includes a sum in each year for rental of additional equipment for the *computer science curriculum at Mankato State College*. Funds from any and all sources shall be sought to augment the moneys herein appropriated and no such additional equipment may be rented until non-state moneys have been obtained which when added to the amount provided herein are sufficient to cover the cost of the expanded program.

This appropriation includes a sum in each year for development of an accounting, budget, and management system for the state colleges.

This appropriation includes a sum in each year for teachers training programs in special education at Mankato, Moorhead and St. Cloud State Colleges; nurses training programs at Mankato and Winona State Colleges; and a dental hygienist program at Mankato State College.

This appropriation includes a sum in each year for development, including equipment, of *innovative teacher education programs*.

The amounts appropriated in subdivisions 1 and 2 include a sum in each year for recruitment of faculty. Candidates for twelve month administrative positions in the state college board central office or in a state college and academic positions who have been invited by the state college board for interview may be reimbursed for travel and subsistence expenses in the same manner and in the same amounts as state officers and employees. This reimbursement may be made from college imprest cash funds. The state college board shall reimburse the college imprest cash funds for expenses paid to candidates in accordance with established procedure.

All receipts of every kind, including but not limited to student's tuition and fees, federal receipts, aids, contributions, and reimbursements in all state colleges are reappropriated to the state college board, but subject to budgetary control by the commissioner of administration, except the following receipts not subject to budgetary control by the commissioner of administration:

- (a) those attributed to dormitory functions handled under Minnesota Statutes 136.31 to 136.38, and
- (b) those attributable to college activity funds (including, for example, receipts from vending machines in buildings other than dormitories and student unions), and
- (c) those attributable to grants for special projects, institutes, and similar activities

A report shall be submitted to the 67th session of the legislature as to the use of all such excepted funds.

Notwithstanding any other law to the contrary, reimbursements are appropriated for use during the fiscal year in which they are received.

The state college board shall review the administrative organization of each of the state colleges and develop a policy relative to number and types of non-teaching positions that should be established at each of the state colleges.

The state college board may allocate, not to exceed \$3,000 annually, to each college president and the office of the chancellor for miscellaneous expenses in connection with the state college system. *The provisions of Minnesota Statutes 1967, Chapter 16 shall not apply to such expenditures but the state college board shall prescribe the manner, amount, and purpose of such expenditures and report thereon to the 1971 legislature.*

Notwithstanding the provisions of Minnesota Statutes 1967, Section 136.06, or any other law to the contrary, expenses incurred in travel outside of the state of Minnesota shall be paid upon prior authorization of the chief executive officer or president of the state college board. No other approval shall be required.

The student union fee to be charged each student in attendance at each state college shall not exceed \$10 per quarter. This is in lieu of the amount prescribed by Minnesota Statutes 1967, Section 136.11, Subdivision 6. The other provisions of such subdivision shall continue in force and effect.

Notwithstanding any provision in Minnesota Statutes 1967, Chapter 16, which may indicate the contrary, when the state college board so requests, technical educational equipment may be procured for the state colleges either by brand designation or in accordance with standards and specifications which the board may promulgate.

In addition to the fees prescribed by Minnesota Statutes 1967, Section 136.11, the state

college board may prescribe fees to be charged students for college activities, functions, and purposes.

Notwithstanding any other provision of law to the contrary, the state college board may make refunds to students for tuition, activity fees, union fees and any other fees from imprest cash funds. The imprest cash fund shall be reimbursed periodically by checks or warrants drawn on the funds and accounts to which the refund should ultimately be charged. The state college board shall obtain the approval of the public examiner for the procedures used in carrying out the provisions of this paragraph.

The state college board may waive tuition on institutes, courses or projects when the sponsor pays all costs.

Placement Service Registration fee, \$10.

Provided that the above fee shall be charged to each student or graduate upon registration with the college placement service.

The state college board is authorized to contract for hospital benefits coverage and medical benefits coverage for students in the same manner as authorized by Minnesota Statutes 1967, Section 43.45.

This appropriation includes \$2,842,595 the first year and \$2,924,992 the second year for salary adjustments for promotion and special merit increases for the faculty.

This appropriation includes \$50,000 each year which shall be distributed among the major affiliated teaching hospitals operated by political subdivisions of this state participating in the program of providing training to undergraduate medical students of the university of Minnesota medical school during their clinical years. The distribution shall be made in the proportion of the man-weeks of training of such students at each such training hospital as compared to the total man-weeks of training of all such students at all such training hospitals during the preceding year. This amount

is in addition to the amounts paid by the university to such hospitals from any source for any purpose. These payments shall not be used to reduce any payments for salary or other support that have been made by the university for this purpose.

This appropriation includes \$25,000 each year for planning a graduate curriculum in social work at the Duluth campus of the university.

The board of regents of the university may use any money not specifically appropriated for other purposes for acquiring land by purchase or condemnation. In case it is desired to use the fund for the acquisition of land, the power of eminent domain may be exercised in accordance with Minnesota Statutes 1967, Chapter 117.

The university of Minnesota may establish and conduct a school for the instruction of persons in law enforcement and the governing body of any political subdivision of this state may authorize the attendance upon such school of any law enforcement officer under its jurisdiction and may provide for the payment of the expenses of such person while in attendance at such school from the general funds of such political subdivision. To each *person satisfactorily completing the prescribed course of instruction in the school as established* shall be issued a certificate of graduation or diploma stating that the holder has graduated therefrom.

The university of Minnesota may establish a program of college level education in law enforcement and police science. If established, such program shall include appropriate courses for persons in law enforcement and also for students preparing for careers in law enforcement and police science.

This appropriation includes \$10,000 each year for the rural nursing coordinator program.

This appropriation includes \$38,318 the first year and \$40,318 the second year for ore estimates to be furnished by the school of mines at the university of Minnesota for the department of taxation.

Provided that these appropriations for maintenance and improvements are made from revenues accruing to the university from:

- (1) the investments of the permanent university fund; and

(2) the occupation tax on iron ore.

If such revenues are insufficient, the remainder of such appropriations are advanced and appropriated from any moneys in the state treasury credited to the general fund. The income derived from the investment of the permanent university fund is hereby appropriated to the board of regents pursuant to Laws 1963, Chapter 567, Section 2.

For the purposes of these appropriations it is estimated that the income to be derived from the investment of the permanent university fund will not exceed \$1,925,750 for the first year and \$1,995,771 for the second year. If at the end of any fiscal year there are unexpended revenues accruing to the university from the occupation tax on iron ore, the general fund shall be reimbursed therefrom to the extent that payments have been made from the general fund during such fiscal year pursuant to these appropriations. The board of regents shall certify to the state auditor at the end of each quarter the amounts of earnings derived from the investment of the permanent university fund and if the income derived from the investment of the permanent university fund during any fiscal year exceeds the amounts herein stated, the amounts payable from the general fund shall be reduced accordingly.

For budgetary purposes it is estimated that the foregoing appropriation from the general fund will not exceed the sum of \$63,312,997 the first year and \$70,682,098 the second year.

Notwithstanding the provisions of the education code, the provisions of the laws relating to income and excise taxes and the disposition thereof, or any other law to the contrary, the appropriations in this section for the fiscal years 1970 and 1971 for foundation program aid shall be distributed pursuant to Minnesota Statutes 1967, Section 124.17 as amended and Section 124.211 as amended.

The amounts appropriated by this section are to be paid from the elementary and secondary schools' share of funds derived from the occupation tax on iron ore to the extent available and the remainder from the general fund.

Of the amounts appropriated above \$25,000 the first year and \$50,000 the second year is for the training of teachers and administrators in the Minnesota Indian education portion of this program.

Notwithstanding any contrary provisions included in the act initiated by Senate File 1388 as amended, the appropriations made by Section 2, Subdivisions 1 and 2, of this act include funds for the cost to the department of education for administering this program and are the only state funds available for this purpose.

Any unexpended balance remaining in the first year shall not cancel but shall be available for the second year of the biennium.

(b) AFDC Students 475,000

Any unexpended balance remaining in the first year shall not cancel but shall be available for the second year of the biennium.

(c) Indian Students 155,000

Any unexpended balance remaining in the first year shall not cancel but shall be available for the second year of the biennium.

The commission shall submit a written progress report on or before November 15, 1970, to the appropriate standing committees of the House and Senate. The report shall include recommendations as to the future of the program.

Any unexpended balance remaining in the first year shall not cancel but shall be available for the second year of the biennium.

Subdivision 1. Hennepin County General Hospital 400,000

This appropriation is for development and implementation of the family practice residency program.

There is further hereby appropriated out of any money in the state treasury not otherwise appropriated the sum of \$29,000 payable July 1, 1969, and \$29,000 payable July 1, 1970, to each county now or hereafter having not less than 60 or more than 65 whole or fractional congressional townships, and in which 85 percent or more of the area therein is within a federal or state forest area.

Subd. 3. The money appropriated in subdivision 1 and subdivision 2 shall be paid to the county treasurer by the state treasurer to be placed in such county funds as the county board may direct and the other half to be paid by the county treasurer to the various *school districts of the respective counties* as follows:

- (1) One-half thereof in the proportion that the federal or state lands within each district bear to the total area of federal and state lands within such county.
- (2) The other one-half in the proportion that the average school attendance within each district bears to the total average

The state junior college board is authorized to establish activity funds, except for dormitory purposes, and imprest cash funds, to waive tuition charges and to act as agent and accept the benefits of public law 88-452, known as the economic opportunity act of

1964, as amended, and public law 85-864, known as the national defense education act of 1958, as amended, to the same extent and subject to the same conditions as such authority is vested in the state college board. Minnesota Statutes 1967, Sections 136.045, 136.142, 136.143, 136.144, 136.171, 136.22, and 352.01, Subdivision 2a (6) also apply to the state junior college board and the state junior colleges in the same manner as to the state college board and the state colleges.

All receipts attributable to the college activity funds and deposited in the state treasury are hereby reappropriated to the state junior college board and are not subject to budgetary control as exercised by the commissioner of administration.

Whenever an appropriation to any department or agency for salaries discloses an approved complement, that department or agency is limited in the employment of the number of full time equivalent persons including part time and seasonal employees indicated by such approved complement.

Except as otherwise provided in this act, additional employees over the number of the approved complement may be employed on the basis of public necessity or emergency with the written approval of the governor, but the governor shall not approve such additional personnel until he has consulted with the legislative advisory committee created by Laws 1943, Chapter 594, and such committee has made its recommendation upon the matter. Such recommendation shall be advisory only. Failure or refusal of the committee to make recommendation promptly shall be deemed a negative rec-

ommendation. The provisions hereof shall extend to any other agency to which the present authority of the legislative advisory committee may be transferred, but shall be deemed to be repealed in case such authority shall be abolished.

Sec. 26. **General fund.** (a) For the purpose of supplying deficiencies in the general fund, the treasurer may temporarily advance money to that fund from other public funds, not exceeding in the aggregate \$150,000,000 in any year; provided that no fund shall be so impaired thereby that all proper demands thereon cannot be met. The power hereby conferred upon the treasurer is in addition to any other similar authority conferred by law.

(b) Whenever it becomes necessary in order to meet the current demands upon the general fund for the payment of warrants issued or to be issued against said fund pursuant to appropriations, and it appears that the deficiencies in such fund cannot be temporarily supplied under (a) hereof, the governor, after securing the recommendation of the legislative advisory committee, which shall be advisory only, or if there be no such committee, the governor, the state auditor, and the state treasurer, as a special committee, at any time prior to June 30, 1971, may authorize the issuance and sale of certificates of indebtedness of the state, pursuant to and in accordance with Article IX, Section 6, of the Constitution, in anticipation of the collection of taxes levied for the general fund, and any other revenues appropriated to that fund for expenditure during the biennium beginning July 1, 1969, in such amount as may be necessary to pay such warrants. The certificates shall be executed by the state auditor and attested by the state treasurer under their official seals, and shall be numbered serially and shall be of such denomination and shall bear such dates of issue and maturity and such rates of interest as the auditor shall determine, provided that no such certificates shall mature later than June 30, 1971, and provided further, that the aggregate amount of such certificates at any time outstanding, plus the aggregate amount of advances made under (a) and not previously repaid, shall not exceed \$150,000,000 and shall not exceed the limitation stated in the Constitution, Article IX, Section 6, Subdivision 3. The failure or refusal of the advisory committee, if there be one, to make a recommendation promptly shall be deemed a negative recommendation. If the moneys on hand in the general fund are not sufficient to pay any such certificate at maturity, with interest thereon, the same may be refunded by the issuance of any certificates maturing not later than December 1, 1972. If moneys on hand in said fund are not sufficient to pay all certificates of indebtedness issued thereon and outstanding on December 1, 1971, the state auditor shall levy a tax for the payment of all such

certificates and interest thereon, in accordance with the Constitution, Article IX, Section 6, Subdivision 3. Certificates issued and sold pursuant to this act shall be retired out of the receipts of the general fund appropriated to the payment of warrants which are issued against said fund but are taken up with the proceeds of such certificates. Such sums as may be necessary are hereby appropriated from the general fund and made available for the biennium beginning July 1, 1969, to pay the interest upon such certificates.

(c) The state board of investment, or its successor in authority, is hereby authorized to purchase the certificates of indebtedness herein authorized for any fund which it is authorized to invest, provided, it shall not purchase any such certificates bearing interest at a rate of less than one and one-half percent per annum.

The authority conferred by this section is in addition to any similar authority otherwise provided by law for the same purposes.

Sec. 27. Any moneys made available to any state department or agency by this act by appropriation, transfer or otherwise for the payment of salaries is a source of revenue to such department or agency under the provisions of Minnesota Statutes, Section 355.50 and 352.04, Subdivision 5.

Sec. 28. [136.63] [Subd. 1a.] **State junior colleges.** Subdivision 1. The state junior college board shall prescribe the courses of study including undergraduate academic programs, training in semi-professional and technical fields, and adult education, conditions of admission, fees and tuition to be paid by students, requirements for graduation, and such suitable rules and regulations necessary for the operation of such junior colleges. Rules and regulations so prescribed shall not be subject to the requirements of the administrative procedure act or any other law requiring notice, hearing or the approval of the attorney general prior to adoption.

Subd. 2. Subdivision 1 takes the place of Minnesota Statutes 1967, Section 136.63, Subdivision 2.

Sec. 29. In order to enable the state to match the cost of any program under Title I of the Higher Education Act of 1965, any receipts accruing to any state department or agency by reason of service performed for the university of Minnesota in connection with such program shall be deposited in the state treasury. Such receipts are hereby reappropriated to the department or agency making the deposit, to be used as part of the state's 25 percent

Sec. 30. **[136.821] Administrative expenses.** Notwithstanding the provisions of any law to the contrary, the administrative expenses of the supplemental retirement plan established pursuant to Minnesota Statutes, Sections 136.80 to 136.87 shall be paid from the portion of the cash realized on the redemption of shares pursuant to Minnesota Statutes, Section 136.82, Subdivision 1, clause (5) which becomes the property of the supplemental retirement account of the teachers retirement fund. The balance of said cash after payment of said expenses shall be prorated as thereafter provided in Minnesota Statutes, Section 136.82, Subdivision 1, clause (5). The amount of \$12,500 is hereby annually appropriated to the teachers retirement association from the cash balance described herein for said purposes.

Sec. 31. **[124.281] Gross earnings refund, second half of biennium.** A school district eligible for tax refund during the first year of the biennium under the provisions of Minnesota Statutes 1967, Sec. 124.28, shall also be entitled to such a refund during the second year of the biennium whether or not the district meets the formula requirements of the law for the second year, but not to exceed, however, the refund received for the first year of the biennium.

Sec. 32. **[136.602] Additional junior colleges.** Subdivision 1. In addition to the state junior colleges authorized in Minnesota Statutes 1967, Sections 136.60 and 136.601, two junior colleges are established under the jurisdiction of the state junior college board, one of which shall be located at Fairmont and the other at a site to be designated by the state junior college board at one of the sites recommended by the higher education coordinating commission; namely, Alexandria, Cambridge, Hutchinson, New Ulm and Owatonna. This direction does not imply rejection of the remaining named sites, nor does it preclude legislative selection of alternative or additional sites.

Subd. 2. There is appropriated to the state junior college board and the commissioner of administration jointly, from the general fund in the state treasury, the sum of \$200,000 or so much thereof as may be necessary for planning and architectural services in connection with the junior colleges established in this section. Be it enacted by the Legislature of the State of Minnesota:

Section 1. State government; public buildings; appropriation. Except as otherwise provided in this act, the sums hereinafter set forth, or so much thereof as may be necessary, are hereby appropriated out of the general fund in the state treasury or such other funds as designated, for the purposes specified in the following sections of this act.

Sec. 2. Subdivision 1. To the commissioner of administration to be expended for the purposes and in accordance with the provisions of this act.

Subd. 2. At Anoka State Hospital:

(1) Demolish cottage 5, demolish or sell farm buildings, continue work on roads, parking, and lighting, and install emergency generators for boiler plant and surgery \$50,000

Subd. 3. At Fergus Falls State Hospital:

(1) Remodel heating and ventilating system . . . 50,000

Subd. 4. At Hastings State Hospital:

(1) Of the sum of \$1,800,000 appropriated to the commissioner of administration from the 1965 Minnesota state building fund by Laws 1965, Chapter 882, Section 2, Subdivision 4 (1) for the construction and equipping of one
