#### CHAPTER 121—S. F. No. 228

*An act relating to the transportation of new house trailers, mobile homes, sectional buildings and semi-trailers by towing methods; amending Minnesota Statutes 1967, Section 168.053, Subdivision 2.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Section 168.053, Subdivision 2, is amended to read:

Subd. 2. **Mobile homes and sectional buildings; towing.** Notwithstanding any provisions of subdivision 1 inconsistent herewith the provisions of sections 168.053 to 168.057 shall also apply to the delivery of new house trailers, *mobile homes, sectional buildings*, and semi-trailers by towing methods whether or not the power unit is a part of the combination being delivered.

#### CHAPTER 122—S. F. No. 410

*An act relating to workmen's compensation; amending Minnesota Statutes 1967, Section 176.131, Subdivision 4.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Section 176.131, Subdivision 4, is amended to read:

Subd. 4. **Workmen's compensation; pre-existing injuries.** If the employee's pre-existing physical impairment has been caused by a personal injury for which medical reports, showing the impairment have been filed with the commission and for which ~~compensation~~ *a monetary benefit in excess of medical expense*, has

CHAPTER 123—S. F. No. 554

*An act relating to the firemen's relief association and the firemen's pension fund in the city of Minneapolis; amending Laws 1965, Chapter 519, Section 1, as amended; repealing Laws 1965, Chapter 519, Section 2.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1965, Chapter 519, Section 1, as amended by Laws 1967, Chapter 819, Section 1, is amended to read:

Section 1. **Minneapolis, city of; firemen's relief association.** Notwithstanding the provisions of Minnesota Statutes 1965, Section 69.48, to the contrary, when a service pensioner, disability pensioner, or deferred pensioner, or an active member of a relief association dies, leaving

(1) A widow who was his legally married wife, residing with him, and who was married to him while or prior to the time he was on the payroll of the fire department; and who, in case the deceased member was a service or deferred pensioner was legally married to the member at least three years before his retirement from the fire department; or

(2) A child or children who were living while the deceased was on the payroll of the fire department, or born within nine months after the decedent was withdrawn from the payroll of the fire department, the widow and the child or children shall be entitled to a pension or pensions, as follows:

(a) To the widow, a pension of not less than 17 units, and not to exceed the ~~sum~~ *total* of ~~20~~ 21 units per month, as the bylaws of the association provide, for her natural life; provided, that if she shall remarry then the pension shall cease and terminate as of the date of her remarriage;

(b) To the child or children, if their mother be living, a pension of not to exceed eight units per month for each child up to the
