#### CHAPTER 135—S. F. No. 251

*An act relating to compensation of grand jurors, petit jurors and talesmen; amending Minnesota Statutes 1967, Section 357.26, Subdivision 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Section 357.26, Subdivision 1, is amended to read:

**357.26 Jurors; compensation.** Subdivision 1. Each grand juror, petit juror and talesman shall receive ~~\$6~~ *\$10* for each day in actual attendance in the district court, *except in counties containing a city of the first class where such persons shall receive \$6 for each day in actual attendance*, and mileage for each such day in actual attendance at the rate of ~~seven and one half~~ *nine* cents for each mile of the distance from his residence to the place of trial or hearing and from the place of trial or hearing to his residence, the distance to be computed by the usually traveled route, *or 50 cents, whichever amount is greater.*

#### CHAPTER 136—S. F. No. 523

*An act relating to wild animals; placing antelope on the protected list; amending Minnesota Statutes 1967, Section 100.27, Subdivision 1.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Section 100.27, Subdivision 1, is amended to read:

**100.27 Game and fish; antelope; protection; seasons.** Subdivision 1. Except as otherwise specifically provided, there shall be no open season on moose, elk, caribou, *antelope*, marten, fisher, Canada spruce grouse, or wild turkeys.

CHAPTER 137—S. F. No. 540

*An act authorizing the conveyance by the state of certain land in Big Stone county.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Conveyance of state lands; Vernon B. Lund.** The governor, upon recommendation of the commissioner of administration and on behalf of the state of Minnesota shall transfer and convey by quitclaim deed to Vernon B. Lund for such consideration or terms as agreed upon, the state of Minnesota's interest in the following described land located in Big Stone County, Minnesota, to-wit:

Lots 7, 8, 9, 10, and the North 1/2 of Lot 6, Block 10 in the townsite of Peninsula, the city of Ortonville, Minnesota.

Became law without governor's signature.
