

Application for assistance under sections 256.72 to 256.87 shall be made to the county agency of the county in which the dependent child is residing. If the child is not residing within the state at the time of application but is eligible for assistance, the application may be made to the agency of the county where the child is present and forwarded to the agency of the county where the child last resided. The application shall be in writing or reduced to writing in the manner and upon the form prescribed by the state agency and verified by the oath of the applicant or *in lieu thereof shall contain the following declaration which shall be signed by the applicant: "I declare that this application has been examined by me and to the best of my knowledge and belief is a true and correct statement of every material point"*. The application shall be made by the person with whom the child will live and contain information as to the age and residence of the child and such other information as may be required by the rules and regulations of the state agency. One application may be made for several children of the same family if they reside with the same person.

CHAPTER 479—S. F. No. 1753

An act relating to Koochiching county; authorizing the county board to provide abstracting services.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Koochiching county; abstracting services.** The county board of Koochiching county may provide for and acquire a tract index and operate a business of making and furnishing abstracts of title, and do all things necessary to provide said service including hiring necessary personnel and providing necessary supplies therefor.

Sec. 2. If the county of Koochiching operates an abstract business, the county board may, by resolution, establish such charges for making and furnishing abstracts of title as are provided by law.

Sec. 3. If the county of Koochiching operates an abstract business, the county board may, by resolution, set the salary of the register of deeds including such additional compensation for addi-

tional duties to be performed by the register of deeds as a registered abstracter as defined in Minnesota Statutes, Section 386.61, Subdivision 2, Clause (2). After a resolution providing for such additional duties and compensation is adopted, any fees charged and collected by the register of deeds for services he renders as a registered abstracter as defined in Minnesota Statutes, Section 386.61, Subdivision 2, Clause (2), shall be paid to the county in compliance with the provisions of Minnesota Statutes, Section 386.015, Subdivision 5, and no such fees shall be retained by the register of deeds as personal compensation as therein provided.

Sec. 4. This act takes effect when approved by the county board of Koochiching county and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

CHAPTER 480—S. F. No. 2527

An act designating and establishing the route of "Glacial Ridge Trail".

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **[161.14] Highways; Glacial Ridge Trail.** Subdivision 1. **[Subd. 15.]** The following route is named and designated the "Glacial Ridge Trail":

Beginning at the junction of Trunk Highway No. 71, at its intersection with Trunk Highway No. 12, in Willmar; thence extending north and northeasterly along Trunk Highway No. 71 to its intersection with Kandiyohi County Highway No. 90; thence extending east along said Highway No. 90 to its junction of Kandiyohi County State Aid Highway No. 9; thence extending north and northeasterly along said Highway No. 9 to its junction of Kandiyohi State Aid Highway No. 26; thence extending east along said Highway No. 26 to its junction of Kandiyohi State Aid Highway No. 8; thence extending north along said Highway No. 8 to its junction of Kandiyohi State Aid Highway No. 10, south of Green Lake; thence northerly along said Highway No. 10 to its junction of Kandiyohi State Aid Highway No. 30 in Spicer; thence extending northerly and easterly along said High-
