(i) (h) Who comes within the provisions of subdivision 5, but whose conduct results in whole or in part from parental neglect.

CHAPTER 504—H. F. No. 1625

An act relating to the city of Moorhead; authorizing the issuance by the city of its bonds for automobile parking facilities.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Moorhead, city of; parking facilities.** The city of Moorhead is authorized by resolution of its city council to issue general obligation bonds of the city for the purpose of the acquisition and betterment of automobile parking facilities pursuant to Minnesota Statutes, Section 459.14. No vote of the electors shall be required if the city council pledges special assessments to be levied or net revenues derived from rates and charges to be collected for the facilities, or both, in amounts sufficient to provide for payment of not less than 50 percent of the principal and interest on the bonds.

Sec. 2. This act takes effect when approved by the city council of the city of Moorhead and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 505—H. F. No. 1958

An act relating to Sherburne county, and to planning and zoning activities therein; amending Laws 1967, Chapter 1, Section 1.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1967, Chapter 1, Section 1, is amended to read:

Section 1. **Sherburne county; planning and zoning.** Notwithstanding the time limit provisions of Minnesota Statutes, Section 394.34, or any other provision of law to the contrary, in Sherburne county any interim zoning map or interim zoning ordinance or interim resolution relating to zoning heretofore adopted by the board of county commissioners shall be effective until July 1, ~~1969~~ 1971.

Sec. 2. *This act takes effect upon its approval by the board of county commissioners of Sherburne county and upon compliance with the provisions of Minnesota Statutes, Section 645.021.*

CHAPTER 506—H. F. No. 2340

An act permitting villages and towns to join in maintaining cemeteries; amending Minnesota Statutes 1967, Section 471.24.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Section 471.24, is amended to read:

471.24 **Villages and towns; cemetery maintenance.** Where a village or town owns and maintains an established cemetery or burial ground, either within or without the municipal limits, the village or town may, by mutual agreement with contiguous villages and towns, each having an assessed valuation of not less than \$500,000, join together in the maintenance of such public cemetery or burial ground for the use of the inhabitants of each of such municipalities; and each such municipality is hereby authorized, by action of its council or governing body, to levy a tax or make an appropriation for the support and maintenance of such cemetery or burial ground; provided, the amount thus levied or appropriated by each municipality shall not exceed a total of \$2000 in any one year except that any of the aforesaid towns the assessed valuation of which exceeds ~~\$3,000,000~~ \$2,000,000 may levy \$3000 in any one year.
