

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Scott county; general revenue tax levy.** Notwithstanding the provisions and limitations of Minnesota Statutes, Section 275.09, or any other law, to the contrary, the board of county commissioners of the county of Scott may levy annually a tax not to exceed 25 mills on the dollar of the taxable valuation of the county for general revenue purposes.

Sec. 2. This act takes effect when approved by the board of county commissioners of the county of Scott, and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

CHAPTER 520—H. F. No. 392

*An act authorizing the commissioner of conservation to sell certain lands in Beltrami county.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Conveyance of state lands; Beltrami county.** The commissioner of conservation is hereby authorized to sell that part of Government Lot 10, Section 36, Township 148, Range 35, in Beltrami county, lying north of the projected east west one quarter line, in the same manner as provided by law for the sale of other state school lands, notwithstanding the fact that such lands lie within the boundary of a state forest. The tract to be sold contains a total of approximately 13.53 acres, more or less.

CHAPTER 521—H. F. No. 702

*An act relating to the tax levy for general revenue purposes in the county of LeSueur.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Le Sueur county; general revenue tax levy.** In addition to the tax levy authorized by Minnesota Statutes, Section 275.09, and any other law, the county board of Le Sueur county may levy annually a tax not to exceed five additional mills on the dollar of the taxable valuation of the county for general revenue purposes.

Sec. 2. This act takes effect when approved by the county board of Le Sueur county, and upon compliance with Minnesota Statutes, Section 645.021.

#### CHAPTER 522—H. F. No. 742

*An act relating to exchange of state lands; amending Minnesota Statutes 1967, Section 94.343, Subdivision 7.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1967, Section 94.343, Subdivision 7, is amended to read:

Subd. 7. **Exchange of state lands; list.** Before giving final approval to any exchange of Class A land, the commission shall hold a public hearing thereon at the capital city or at some place which it may designate in the general area where the lands involved are situated; provided, that the commission may direct such hearing to be held in its behalf by any of its members or by the commissioner or by a referee appointed by the commission. The commissioner shall furnish to the auditor of each county affected a notice of the hearing signed by the state auditor as secretary of the commission, together with a list of all the ~~state~~ lands proposed to be exchanged and situated in the county, and the county auditor shall post the same in his office at least two weeks before the hearing. The county auditor shall also cause a copy of the notice, referring to the list of lands posted in his office, to be published at least two weeks before the hearing in a legal newspaper published in the county. The cost of the publication of the notice shall be paid by the state out of any moneys appropriated for the expenses of the commission.
