

may enter into an agreement, for and in behalf of the state of Minnesota, with the United States of America or any department or agency thereof pursuant to any federal law or rule or regulation promulgated thereunder governing or relating to the availability and use of the funds contemplated by this act and upon such terms and conditions as may be prescribed by the United States of America or any department or agency thereof, notwithstanding the provisions of any state law to the contrary or inconsistent therewith.

Subd. 2. Unless the laws of the United States of America or any rule or regulation promulgated thereunder otherwise direct, the moneys appropriated by this act shall be obligated in accordance with the laws of the state of Minnesota.

Sec. 4. No obligation shall be incurred or any money expended pursuant to the appropriation herein made without the approval and concurrence of the commissioner of employment security.

Sec. 5. This act shall be effective immediately upon its final enactment.

CHAPTER 604—S. F. No. 2248

An act relating to the Minneapolis police department, providing for title of chief and for certain employee appointments; amending Laws 1961, Chapter 108, Sections 1 and 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1961, Chapter 108, Section 1 is amended to read:

Sec. 1. **Minneapolis, city of; police department.** Notwithstanding any provisions of the Minneapolis city charter, veterans' preference, or civil service law, rule, or regulation to the contrary, the superintendent of police of the city of Minneapolis *shall after the effective date of this act have the title and be designated as chief of police of the city of Minneapolis and may appoint the inspector of police, the three deputy inspectors chiefs of police, the inspector of detectives, five inspectors of police, the head supervisor of the*

morals and narcotics squad, section, and the supervisor of license inspector, inspection, such personnel to be appointed from among the members of the Minneapolis police department holding at least the rank of patrolman.

Sec. 2. Laws 1961, Chapter 108, Section 2, is amended to read:

Sec. 2. **Chief to appoint and discharge.** Such positions may be filled by the ~~superintendent~~ chief of police without examination and such appointees may be removed by him at will.

Sec. 3. *This act shall become effective only after its approval by a majority of the governing body of the city of Minneapolis and upon compliance with the provisions of Minnesota Statutes 1967, Section 645.021.*

CHAPTER 605—S. F. No. 2252

An act authorizing conveyance by the state of certain lands in Anoka county to Independent School District No. 11.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **Conveyance of state lands; Independent school district No. 11.** Subdivision 1. The governor, upon recommendation of the commissioner of administration, shall transfer and convey, by quit claim deed in the form the attorney general approves in the name of the state of Minnesota, to Independent School District No. 11, the following described land in Anoka county, to-wit:

The NE 1/4 of the SE 1/4 of Section 9, Township 31, Range 24; lying southwesterly of Trunk Highway marked No. 10; containing approximately 10 acres, more or less.

Subd. 2. The commissioner of administration shall cause the lands to be surveyed and to be appraised by not less than three appraisers, at least two of whom shall be residents of Anoka county. Each appraiser shall before entering upon the duties of his office take and subscribe an oath that he will faithfully and impartially discharge his duties as appraiser according to the best of his ability and that he is not interested directly or indirectly in any of the lands to be appraised, which oath shall be attached to the report of such appraisal.
