

CHAPTER 667—H. F. No. 2111

An act relating to the fees of the abstract clerk in Ramsey county; amending Laws 1945, Chapter 561, Section 4 as amended by Laws 1957, Chapter 855, Section 1 and Laws 1965, Chapter 628, Section 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1945, Chapter 561, Section 4 as amended by Laws 1957, Chapter 855, Section 1 and Laws 1965, Chapter 628, Section 2 is amended to read:

Sec. 4. **Ramsey county; abstract clerk; fees.** The county abstract clerk is permitted to charge, collect and retain for his own use, maximum fees for his services as follows: In the preparation and issuance of each abstract of title or registered property report, ~~60~~ 80 cents for each pertinent and proper entry thereon of a transfer or other instrument affecting title to the premises; but if the proper presentation of the instrument necessitates an entry of more than 200 words, he shall be permitted to charge 20 cents additional for each additional folio thereof; for abstractors certificate, ~~\$3~~ \$5; for report as to taxes or assessments, ~~75 cents~~ \$1.50 for each abstract or continuation thereof; for the first name searched for judgments \$2 each and for each additional name \$1.10 which shall include both state and federal courts; for each name searched for bankruptcies, 25 cents; for each name searched for old age assistance liens, 25 cents; for each name searched for federal tax liens, 25 cents; for every plat or drawing furnished on request with any abstract, such reasonable fee as may seem fit and proper. Provided, however, that the maximum fee permitted to be charged for any abstract of title or continuation as to any one description shall be ~~\$70~~ \$75.

Sec. 2. *This act shall take effect upon its approval by the board of county commissioners of Ramsey county, and upon compliance with Minnesota Statutes 1967, Section 645.021.*

An act relating to police pensions in the city of Saint Paul;

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1955, Chapter 151, Section 1, Subdivision 3, as amended by Laws 1963, Chapter 271, Section 1, is amended to read:

Subd. 3. **St Paul, city of; police pensions.** "Member" means any person regularly employed and entered on the payroll in the police department of the city, on active duty, except those classified as clerical by the Civil Service Rules and Classification of Position of the City of Saint Paul, and except ambulance surgeons, and includes any person who was a member of the police relief association of the city under any previous law. *The term "member" shall also include those persons who were members of the police relief association of the city at the time of their transfer from the bureau of police and fire alarm telegraph of the department of public safety to the department of public works and carried on a public works department payroll after such transfer.*

Sec. 2. *This act shall become effective only after its approval by a majority of the governing body of the city of Saint Paul and upon compliance with the provisions of Minnesota Statutes, Section 645.021.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1955, Chapter 375, Section 3, as amended by Laws 1961, Chapter 376, Section 2, is amended to read:

Sec. 3. **St. Paul, city of; firemen's relief; fireman defined.** A fireman under sections 1 to 29 is one who is regularly entered on the pay-roll of such fire department serving on active duty with a designated fire company thereon or having charge of one or more of the companies and engaged in the hazards of fire fighting;
