city of Minneapolis shall continue at 20 cents per capita, and no levy may be made by Hennepin county on property within the city of Minneapolis pursuant to section 2 of this act.

## CHAPTER 701—H. F. No. 755

## [Coded in Part]

An act relating to the state college board; permitting the board to charge fees for parking facilities and to establish health services at state colleges; appropriating money; amending Minnesota Statutes 1967, Sections 136.11, by adding a subdivision; 169.966, Subdivision 1, and by adding a subdivision.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1967, Section 136.11, is amended by adding a subdivision to read:
- Subd. 7. State colleges; parking facilities and health services. The state college board shall establish a health service at each state college for its students and may charge each student a health service fee in an amount not exceeding \$20 per quarter. The proceeds of the fee shall be used to maintain the health service and equip and construct facilities for it. Proceeds of the fee may be used to contract for health, medical and hospitalization insurance for the students. The proceeds of the fees shall be deposited in the college activity fund and are annually appropriated to the state college board for the purposes of this subdivision.
- Sec. 2. Minnesota Statutes 1967, Section 169.966, Subdivision 1, is amended to read:
- 169.966 State college board to regulate traffic. Subdivision 1. The state college board may from time to time make, adopt, and enforce such rules, regulations, or ordinances not inconsistent with the Highway Traffic Regulation Act, Minnesota Statutes, Chapter 169, as amended, as it may find expedient or necessary relating to the regulation of traffic and parking upon parking facilities and private roads and roadways situated on property owned, leased, or occupied or operated by state colleges.

Sec. 3. Minnesota Statutes 1967, Section 169.966, is amended by adding a subdivision to read:

Subd. 1a. Parking facilities. The state college board may establish rents, charges or fees in an amount not to exceed \$1 per vehicle per day for the use of parking facilities owned, leased, occupied, or operated by the state college board. The money collected by the board as rents, charges or fees in accordance with this subdivision shall be deposited in the college activity fund and is annually appropriated to the state college board for state college purposes and to maintain and operate parking lots and parking facilities.

## CHAPTER 702-H. F. No. 794

An act relating to state parks, recreation reserves, and waysides; providing employee motor vehicle permits for driving motor vehicles therein; amending Minnesota Statutes 1967, Section 85.05, Subdivision 2.

Be it enacted by the Legislature of the State of Minnesota:

- Section 1. Minnesota Statutes 1967, Section 85.05, Subdivision 2, is amended to read:
- Subd. 2. State parks; permits for motor vehicles. Except as provided in clause (b) of this subdivision, no motor vehicle shall enter or be permitted to enter any state park, memorial state park, state recreational reserve or wayside over 50 acres in area unless it has affixed to its windshield in the lower right corner thereof a permit which is provided for hereinafter. The commissioner of conservation shall procure permits in such form as he shall prescribe for each calendar year which by appropriate language shall grant permission to use any state park, memorial state park, state recreational reserve or wayside over 50 acres in area. Permits for each calendar year shall be provided and placed on sale before October 1 next preceding, and may be affixed and used on or at any time after said date until the end of the calendar year for which issued. Such permits in each category shall be numbered consecutively for each year of issue. A fee of \$2 shall be charged for each permit issued, except that permits of appropriate special design may be sold individually at 50 cents covering the use of state parks, memorial state parks, state recreational reserves or waysides under such
