

CHAPTER 125—H.F.No.1000

An act appropriating funds for the payment of expenses in connection with the 1971 meeting of the National Legislative Conference.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. NATIONAL LEGISLATIVE CONFERENCE; APPROPRIATION. There is appropriated from the general fund to the chief clerk of the house of representatives and the secretary of the senate the total sum of \$85,000, to be jointly expended by such officials in payment of expenses in connection with the 1971 meeting of the National Legislative Conference to be held in Minnesota. No expenditure of funds appropriated by this section shall be made until the chief clerk and secretary have consulted with the senate committee on rules and administration and the house committee on rules and legislative administration or their designees and received their recommendations, which shall be advisory only.

Sec. 2. This act is in effect from and after final enactment.

CHAPTER 126—H.F.No.1570

An act relating to education; providing for school board elections in dissolved Independent School District No. 37 and attaching districts.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. INDEPENDENT SCHOOL DISTRICT NO. 37; ELECTIONS. The 1971 annual election in the school district or districts to which dissolved Independent School District No. 37 of Beltrami county is to be attached pursuant to Minnesota Statutes, Section 122.44, shall be conducted as if the attachment had become effective 45 days prior to the election; provided that the final order of the county board has been issued in accordance with the provisions of section 122.44, subdivision 5, and no appeal has been filed under section 127.25. The board of the surviving district shall make such provisions for the election as are necessary, and qualified persons

within the territories to be attached shall be entitled to vote, to be candidates for elective office, and to otherwise fully participate in the election.

CHAPTER 127—H.F.No.1716

An act relating to the city of Willmar; payment of firemen's service pensions.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. WILLMAR, CITY OF; FIREMEN'S SERVICE PENSIONS. Notwithstanding the provisions of Minnesota Statutes, Section 69.06, or any other law to the contrary, the fire department relief association of the city of Willmar may provide in its bylaws for a service pension in an amount not exceeding \$400 per year of service payable as a lump sum benefit to a retired fireman after 20 years service and age 50. The amount of benefit provided to a retiring fireman shall be determined by the bylaws of the relief association, and this amount shall be within the limits provided by this act. The amount of lump sum benefits so determined by the bylaws of the relief association shall not be effective until approved by the governing body of the city of Willmar.

In the event that a fire department member becomes disabled, through sickness or accident, to the extent that his service as an active fireman must be terminated, then he shall be entitled, as of the day of disability, to the proportionate share of the pension to which he would have been entitled had he retired on the date of such disability, without regard to the minimum requirements of age and service years.

Sec. 2. This act is effective upon approval by the governing body of the city of Willmar and upon compliance with the provisions of Minnesota Statutes, Section 645.021.
