An act relating to Ramsey county court commissioner; providing for the functions and powers of the court commissioner.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. RAMSEY COUNTY; COURT COMMISSIONER; POWERS. The Ramsey county court commissioner shall have the power to take acknowledgements of deeds and other written instruments and the powers conferred upon court commissioners by Minnesota Statutes 1969, Section 253A.21.

Sec. 2. **POWERS REPEALED.** Except as provided in section 1 above, the Ramsey county court commissioner shall not have any of the powers provided in Minnesota Statutes 1969, Section 489.02.

Sec. 3. APPROVAL AND COMPLIANCE. This act shall take effect upon its approval by the county board of Ramsey county, and upon the compliance with Minnesota Statutes 1969, Section 645.021.

An act authorizing the conveyance of certain state lands in Nicollet county to Independent School District No. 508.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. CONVEYANCE OF STATE LANDS; INDEPEND-ENT SCHOOL DISTRICT NO. 508. The governor, upon the recommendation of the commissioners of administration and welfare, shall transfer and convey by quitclaim deed, in the form the attorney general approves, in the name of the state of Minnesota, to Independent School District No. 508 of St. Peter, Minnesota, for such consideration and upon such terms and conditions as may be agreed upon, the following described lands in Nicollet county:

The Northwest Quarter of the Southeast Quarter (NW ¼ SE ¼) of Section twenty (20), Township one hundred ten (110) North, Range twenty-six (26) West, Nicollet county, Minnesota, subject to any existing roadway easements, containing 40 acres more or less.
