

CHAPTER 516—H.F.No.681

An act relating to the state fire marshal; requiring the superintendent of each school to conduct fire drills and post the records of such drills for review by the state fire marshal; requiring the superintendent of each school to keep all doors and exits of each such school unlocked during school hours; amending Minnesota Statutes 1969, Section 299F.30.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1969, Section 299F.30, is amended to read:

299F.30 STATE FIRE MARSHAL; SCHOOLS; FIRE DRILLS.
Subdivision 1. It shall be the duty of the state fire marshal, his deputies and assistants, to require teachers of public and private schools and educational institutions to have one fire drill each month and to keep all doors and exits unlocked during school hours.

Subd. 2. Each superintendent, principal or other person in charge of a public or private school, educational institution, children's home or orphanage housing 20 or more students or other persons, shall instruct and train such students or other persons to quickly and expeditiously quit the premises in case of fire or other emergency by means of drills or rapid dismissals at least once each month while such school, institution, home or orphanage is in operation. Records of such drills shall be posted so that such records are available for review by the state fire marshal at all times and shall include the drill date and the time required to evacuate the building.

Subd. 3. Each superintendent, principal or other person in charge of a public or private school, educational institution, children's home or orphanage shall keep all doors and exits of such school, institution, home or orphanage unlocked so that persons can leave by such doors or exits at any time during the hours of normal operation.

CHAPTER 517—H.F.No.693

An act authorizing the Olmsted county commissioners to appoint additional members to the county board of health.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. OLMSTED COUNTY; BOARD OF HEALTH; MEMBERSHIP. Notwithstanding Minnesota Statutes, Section 145.50, Subdivision 2, and any other provision of law, the board of county commissioners of Olmsted county may appoint two additional members to the Olmsted county board of health for a total board of seven. One of the members shall be a county commissioner for Olmsted county. The additional two members shall serve for terms as provided in Minnesota Statutes, Section 145.50, Subdivision 3.

Sec. 2. This act is effective upon approval by the board of county commissioners of Olmsted county, and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 518—H.F.No.694

An act authorizing Olmsted county to establish, operate, and maintain refuse disposal facilities; amending Laws 1969, Chapter 860, Sections 1 and 3, and by adding a section.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1969, Chapter 860, Section 1, is amended to read:

Section 1. OLMSTED COUNTY; REFUSE DISPOSAL. The board of commissioners of Olmsted county may acquire by purchase, lease, gift, or by condemnation as provided by law, any land or interest in land within the county which the county board deems suitable for use as refuse disposal facility sites. The county board may establish refuse disposal facilities on such sites and may hold, improve, maintain, supervise, control, and operate the same for said purposes. For purposes of this act, "refuse disposal facilities" shall may include public dump grounds, sanitary land fill facilities, incinerators, or refuse composting facilities, refuse collection, refuse compaction, and transportation of refuse.
