Sec. 2. There is appropriated to the governor's council on aging from the general fund the sum of \$50,000 for the purposes of this act.

## CHAPTER 939—S.F.No.994

[Not Coded]

*An act authorizing the commissioner of natural resources to cooperate in the construction and modification of certain water control structures located in Kanabec county; appropriating money therefor.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **KNIFE RIVER DAM; WATER CONTROL; APPROPRIATION.** In order to maintain a more desirable range of water levels on Knife Lake, Kanabec county, the commissioner of natural resources is authorized to enter into a cooperative agreement with Kanabec county, the Kanabec soil and water conservation district, and with other state, federal and local agencies for the construction of a dam across Knife river downstream from the outlet of Knife Lake, and for the modification or removal of the existing state-owned dam at the outlet of Knife Lake.

Sec. 2. Before the construction authorized in section 1 is started, the sponsoring agency shall apply to the commissioner of natural resources for a permit as required by Minnesota Statutes, Chapter 105. In issuing such permit, the commissioner shall require that the said agency acquire by gift, purchase or condemnation all necessary lands and rights or easements in lands which will be affected by such construction; and may attach such conditions as to design, construction, maintenance and operation of the structures as he may find advisable and necessary in the public interest.

Sec. 3. There is hereby appropriated to the commissioner of natural resources \$50,000 for the purposes of this act. The commissioner is hereby authorized to transfer to the sponsoring agency such part of these funds as required under the terms of the agreement authorized in section 1, provided that such agreement shall contain:

(1) Provisions that the county of Kanabec and the Kanabec soil and water conservation district will remove the existing state-owned dam at the outlet of Knife Lake;

(2) Provisions that the county of Kanabec and the Kanabec soil and water conservation district will be responsible for all maintenance and repair of the reconstructed dam and that they will request no further funds from the state in connection with the reconstructed dam; and

(3) Provisions that sufficient funds for the entire cost of land rights, contingency, installation, old dam removal and contract administration in connection with the proposed dam reconstruction according to the plans of the United States soil conservation service be made available by the local and federal agencies involved.

Provided further, that no state funds shall be expended until proof of adequate funding for the total costs of such dam project be supplied to the commissioner of natural resources.

#### CHAPTER 940—S.F.No.1186

*An act relating to the establishment of a mobile health clinic; appropriating money; amending Minnesota Statutes 1969, Chapter 144, by adding a section.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1969, Chapter 144, is amended by adding a section to read:

**[144.076] PUBLIC HEALTH; MOBILE CLINIC.** The department of health may establish, equip, and staff with its own members or volunteers from the healing arts, a mobile unit, or units to travel in and around poverty stricken areas and Indian reservations of the state on a prescribed course and schedule for diagnostic and general health counseling, including counseling on and distribution of dietary information, to persons residing in such areas. For this purpose the department of health may purchase and equip suitable motor vehicles, and furnish a driver and such other personnel as the department deems necessary to effectively carry out the purposes for which these mobile units were established.
