

hold another "on sale" license in its own right, but such license vested by the authority shall expire upon termination of the contracted event. The fee for such license to the authority shall be fixed by the governing body of the city of St. Paul. Such liquor license shall be issued in accordance with the statutes applicable to the issuance of "on sale" liquor licenses in cities of the first class not inconsistent herewith and in accordance with the charter and ordinances of the city of St. Paul not inconsistent herewith and shall limit the sale of intoxicating liquor to ~~members and guests of any person or organization leasing space in the civic center for the purpose of conducting patrons of the entire civic center complex who gather therein for~~ any convention, banquet, conference, meeting, theatrical event or social affair, and ~~but~~ shall prohibit the sale of intoxicating liquor to the public or to any persons attending or participating in any athletic event being held on the civic center premises.

Sec. 2. This act shall become effective only after its approval by a majority of the governing body of the city of Saint Paul and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

## CHAPTER 397—H.F.No.1551

[Not Coded]

*An act relating to the county of Ramsey and the city of Saint Paul; authorizing the rendering of emergency or lifesaving service by a physician's trained mobile intensive care paramedic; under certain circumstances granting immunity from civil liability for good faith emergency lifesaving services rendered by physician's trained mobile intensive care paramedics and also for physicians who render medical advice and instructions to such paramedics while the paramedics are in the performance of lifesaving services.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **RAMSEY COUNTY AND ST. PAUL, CITY OF; PARAMEDIC MOBILE UNIT; DEFINITIONS.** As used in sections 1 to 6, "physician's trained mobile intensive care paramedic" means a person who:

(1) Is an employee of the county of Ramsey or the city of Saint Paul;

(2) Has been specially trained in emergency cardiac and non-cardiac care by a licensed physician in a training program certified by the state board of health or the state board of medical examiners and is certified as qualified to render the emergency lifesaving services enumerated herein.

Sec. 2. The city of Saint Paul and the county of Ramsey are hereby authorized to maintain a staff of physician's trained mobile intensive care paramedics.

Sec. 3. Subdivision 1. Notwithstanding any other provision of law, physician's trained mobile intensive care paramedics may do any of the following:

- (1) Regular rescue, first aid and resuscitation services;
- (2) During training may administer parenteral medications under the direct supervision of a licensed physician or a registered nurse;
- (3) Perform cardiopulmonary resuscitation and defibrillation in a pulseless, nonbreathing patient;
- (4) Administer intravenous saline or glucose solutions;
- (5) Administer parenteral injections in any of the following classes of drugs,
  - (a) antiarrhythmic agents;
  - (b) vagolytic agents;
  - (c) chronotropic agents;
  - (d) analgesic agents;
  - (e) alkalinizing agents;
  - (f) vasopressor agents;
  - (g) diuretics;
- (6) Administer, perform and apply all other procedures, drugs and skills in which they have been trained and are certified to give, apply and dispense.

But at all times before undertaking the actions authorized by clauses (3), (4), (5) and (6), paramedics shall make and continue to make, during the course of an emergency, attempts to establish voice communications with and receive instructions from a licensed physician who has been associated with the dispensing of emergency cardiac and noncardiac medical care. Additionally, the paramed-

ics shall make and continue to make, during the course of what they believe to be a cardiac emergency, attempts to telemeter to a licensed physician, who has been associated with the dispensing of cardiac medical care, an electrocardiogram of the person being treated.

Subd. 2. Nothing contained in this act shall be construed to change existing law as it relates to delegation by a licensed physician of acts, tasks or functions to persons other than physician's trained mobile intensive care paramedics.

Sec. 4. No licensed physician or registered nurse, who in good faith gives emergency instructions to a certified physician's trained mobile intensive care paramedic at the scene of an emergency, or while in transit to and from the scene of such emergency, shall be liable for any civil damages as a result of issuing such instructions.

Sec. 5. No certified physician's trained mobile intensive care paramedic, who in good faith renders emergency lifesaving care and treatment as set forth in this chapter, shall be liable for any civil damages because of rendering such care and treatment.

Sec. 6. This act shall become effective only after its approval by a majority of the governing body of the county of Ramsey and a majority of the governing body of the city of Saint Paul, and upon compliance with Minnesota Statutes, Section 645.021.

## CHAPTER 398—H.F.No.1515

*An act relating to decedents' estates; revising a spouse's power to elect against a will; amending Minnesota Statutes 1971, Section 525.215.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1971, Section 525.215, is amended to read:

**525.215 PROBATE CODE; ELECTION OF SPOUSE TO TAKE AGAINST WILL.** A spouse electing under sections 525.213 to 525.216 also must elect to take against the will, if he spouse is a beneficiary thereunder, and against all other conveyances within the scope of section 525.213 of which he spouse is a beneficiary. A spouse electing to take against the will pursuant to section 525.212
