

Subd. 2. The annuity of a widow of a member of the highway patrol who retired or separated from active service prior to July 1, 1965, and the widow of a highway patrolman who dies in service prior to the effective date of Laws 1969, Chapter 693, and who on the effective date of this act is receiving an annuity of less than \$125 per month, shall thereafter be increased to \$125 per month.

Subd. 3. The annuity of a widow currently receiving an annuity by way of the state police officers retirement fund where there was no option of eligibility, shall on the effective date of this act be increased to \$125 per month.

Subd. 4. The annuity of any widow granted or supplemented by this section shall cease in the event of remarriage of the recipient.

Sec. 7. [352B.29] Notwithstanding other provisions of chapters 352 and 352B as amended, effective July 1, 1973, all powers, duties, responsibilities, books, papers and records of the highway patrolmen's retirement association and of the officers of the highway patrolmen's retirement association are hereby transferred to the Minnesota state retirement system. The officers of the highway patrolmen's retirement association as constituted under chapter 352B as amended are hereby abolished. The members of the highway patrolmen's retirement association shall elect one of their membership to serve as a member of the board of directors of the Minnesota state retirement system. Such member shall be in addition to the board of directors as constituted under chapter 352 and shall serve for a term of four years. The election of such member shall be at a time and in a manner as prescribed by the board. The chief of the highway patrol shall serve as the board member until a member is duly elected.

Sec. 8. Unless otherwise specifically provided this act is effective the day following the final enactment.

CHAPTER 756—H.F.No.1940

An act relating to insurance; automobile insurance plan governing committee; revising the membership of said committee; amending Minnesota Statutes 1971, Section 65B.03.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1971, Section 65B.03, is amended to read:

65B.03 INSURANCE; AUTOMOBILE; GOVERNING COMMITTEE. Subdivision 1. **MEMBERSHIP.** ~~Within 15 days after July 1, 1971, The commissioner shall direct that a ballot be mailed, returnable within 15 days from the date of mailing, to an election be held among every insurer subject to Laws 1971, Chapter 813 this chapter, for the election of a five-member facility governing committee. Each member of the governing committee shall be a participating member and one member shall be elected from each of the following classifications of insurers:~~

- ~~(1) Insurance services office;~~
- ~~(2) Mutual insurance rating bureau;~~
- ~~(3) National association of independent insurers;~~
- ~~(4) All other stock companies;~~
- ~~(5) All other non-stock companies.~~

Each participating member serving on the governing committee shall be represented by a salaried employee of that participating member, and not more than one participating member in a group under the same management shall serve on the governing committee at the same time. The commissioner of insurance or his designee shall be an ex officio member of the governing committee. In the event of a tie vote on any matter before the governing committee, the commissioner or his designee may cast a vote to break the tie. The composition of the governing committee may be revised by recommendation of the existing governing committee and approval of the commissioner.

Subd. 2. **TERMS OF OFFICE.** The committee so elected shall become the ~~initial~~ governing committee of the facility, effective ~~with the adoption of a plan of operation and its approval on a date to be specified~~ by the commissioner. Thereafter, the governing committee shall be elected to serve annual terms. Vacancies shall be filled as provided in the plan of operation.

Sec. 2. This act is effective on the day following its final enactment.
