

~~of land for public use, contribute an equivalent amount in cash based on the undeveloped land value as defined by the regulations, for use as above provided.~~ The subdivision regulations, in setting forth the reasonable portion of each proposed subdivision to be dedicated to the public for public use as provided above, may take into consideration the open space, park, recreational or common areas and facilities which the subdivider has provided for the exclusive use of the residents of the subdivision.
