

Sec. 10. Minnesota Statutes 1971, Section 352.72, Subdivision 4, is amended to read:

Subd. 4. **REFUNDMENT REPAYMENT.** Any person who has received a refundment from the state employees retirement fund ~~prior to July 1, 1961, and who is a member of either the public employees retirement association or the state teachers retirement association~~ a public retirement system included in subdivision 1, may repay such refundment with interest to the state employees retirement fund. If a refundment is repaid to the fund and more than one refundment has been received from the fund, all refundments must be repaid. Such repayment shall be made as provided in Minnesota Statutes 1957, Section 352.23, and acts amendatory thereof, and under such terms and conditions consistent therewith as may be agreed upon with the director. ~~If a refundment has been received from the fund subsequent to June 30, 1961, the provisions of this subdivision do not apply and repayment of refundment can be made only as provided in section 352.23.~~

Sec. 11. Minnesota Statutes 1971, Section 352.04, Subdivision 7, is repealed.

Sec. 12. This act is effective July 1, 1973.

## CHAPTER 222—S.F.No.1013

*An act relating to the city of Fraser in St. Louis county; providing for the dissolution of the city of Fraser.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **FRASER, CITY OF; DISSOLUTION.** The legislature finds that the city of Fraser in St. Louis county is abandoned and no longer serves any function of local government. The city of Fraser is in all things dissolved on the effective date of this act, and all territory contained within the corporate limits of Fraser shall become a part of the town of Balkan.

Sec. 2. The last duly constituted governing body of the city of Fraser shall have custody of any funds of the city of Fraser from its dissolution until January 31, 1974. The said body on the first business day of each week in September, 1973 shall publish in a

legal newspaper in St. Louis county notice of the dissolution of the city and that outstanding lawful claims may be presented to it for payment until December 1, 1973. The said body shall hear, determine and pay all claims on or before January 31, 1974. The reasonable costs of the published notices required herein shall be paid from the funds of the dissolved city. On January 31, 1974 after paying the outstanding lawful claims, the said body shall pay the remaining funds to any town, village or city or non-sectarian, non-profit corporation incorporated under the laws of Minnesota, which corporation or corporations shall use the funds solely for a lawful public purpose. On or before March 1, 1974 the said last duly constituted governing body of the city of Fraser shall file a report of any disbursements made under this act with the secretary of state.

Sec. 3. This act is effective upon final enactment.

## CHAPTER 223—S.F.No.1056

*An act relating to membership on certain boards of the city of Minneapolis; providing for representation of the Minneapolis library board on the city's board of estimate and taxation and eliminating representation of special school district No. 1 of the city of Minneapolis on the city's board of estimate and taxation and library board; amending Laws 1959, Chapter 462, Sections 2, as amended; and 3, Subdivision 2, as amended.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **MINNEAPOLIS, CITY OF; BOARD OF ESTIMATE AND TAXATION.** Notwithstanding any contrary provision of the charter of the city of Minneapolis, one of the members of the board of estimate and taxation of the city of Minneapolis shall be an elected member of the library board of such city who has been so designated by a majority vote of all of the members of said library board.
