

Subd. 4. The widow's monthly pension shall be $\frac{1}{2}$ of 25 percent of the deceased fireman's average annual wage. If the widow remarries the pension shall cease and terminate as of the date of her marriage.

Subd. 5. The monthly pension of each such child shall be $\frac{1}{2}$ of eight percent of the deceased fireman's average annual wage. It shall terminate when the child becomes 18 or marries.

Sec. 6. Retirement pensions, disability pensions and survivors pensions shall be adjusted annually in accordance with the consumer's price index for the preceding calendar year. The national average consumer price index for each year shall be used. In no event, however, shall the retirement, disability or survivor's pension go below what such pension was or would have been in firemen's base year. Base year is defined as (1) the year in which retirement takes place, regardless of whether or not the fireman commences receiving a pension during that year, or (2) the year in which disability takes place, or (3) the year in which death occurs if the fireman dies while an active member of the regular fire department. In the event the consumer's price index falls below its level during the base year, and then rises, the pension shall not be increased until the consumer's price index rises above its level during the base year.

Sec. 7. All retirement pensions, survivorship pensions and disability pensions of firemen who are not full time regular firemen on active duty at the effective date of this act shall remain unchanged by this act, and shall continue as they were established by Laws of 1953, Chapter 348, as amended.

Sec. 8. Laws 1953, Chapter 348, Sections 12, 17, and 20; Laws 1957, Chapter 10; Laws 1961, Chapter 300, Sections 2, 3, and 4; and Laws 1965, Chapter 604, are repealed.

Sec. 9. This act is effective upon approval by the governing body of the city of Red Wing and compliance with Minnesota Statutes, Section 645.021.

Section 1. Minnesota Statutes 1971, Section 488A.01, Subdivision 6, is amended to read:

Subd. 6. **HENNEPIN COUNTY AND ST. PAUL MUNICIPAL COURTS; CRIMINAL JURISDICTION.** (a) The court has jurisdiction to hear, try and determine any charge of violation of:

(1) A criminal law of this state constituting a misdemeanor committed within the county of Hennepin including all of the village of St. Anthony.

(2) Any ordinance, charter provision, rule or regulation of any subdivision of government in the county of Hennepin, including all of the village of St. Anthony or

(3) Any ordinance, charter provision, rule or regulation of the Minneapolis-St. Paul Metropolitan Airports commission.

(b) The court has jurisdiction to conduct preliminary hearings and to exercise all judicial powers incident to preliminary hearing proceedings, on any charge of violation of any criminal law of this state committed within the county of Hennepin.

~~(c) Jurisdiction under sub paragraphs (1) and (2) of paragraph (a) and under paragraph (b) of this subdivision is exclusive for any violation committed in the county of Hennepin, or for any violation committed outside of Hennepin county but within the boundaries of the village of St. Anthony.~~

Sec. 2. Minnesota Statutes 1971, Section 488A.18, Subdivision 7, is amended to read:

Subd. 7. **CRIMINAL JURISDICTION.** (a) The court has jurisdiction to hear, try and determine any charge of violation within Ramsey county of:

(1) A criminal law of this state constituting a misdemeanor,

(2) Any ordinance, charter provision, rule or regulation of the city of Saint Paul, or

(3) Any ordinance, charter provision, rule or regulation of the Minneapolis-Saint Paul Metropolitan Airports Commission,

(4) Any ordinance, rule or regulation of the regents of the University of Minnesota.

(b) The court has jurisdiction to conduct preliminary hearings and to exercise all judicial powers incident to preliminary hearing proceedings, on any charge of violation of any criminal law of this state committed within Ramsey county.

CHAPTER 361—S.F.No.1731

An act relating to courts; establishing salary for court reporters in fourth judicial district; amending Laws 1969, Chapter 568, Section 1, Subdivision 1, as amended; and Minnesota Statutes 1971, Section 486.06, as amended.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Laws 1969, Chapter 568, Section 1, Subdivision 1, as amended by Laws 1971, Chapter 608, Section 1, is amended to read:

Section 1. **DISTRICT COURTS; REPORTERS; COMPENSATION; FOURTH JUDICIAL DISTRICT.** Subdivision 1. Notwithstanding Minnesota Statutes, Section 486.05, or any other law to the contrary, the salary of district court reporters in the fourth judicial district is established at ~~\$14,500~~ \$16,500 per year, as of the ~~effective date of this act~~ January 1, 1973, exclusive of insurance benefits. The salary shall be paid in biweekly installments in the same manner as Hennepin county employees are paid. Such reporters shall not be under the jurisdiction of the Hennepin county personnel board.
