

authority and, in such an event, the Dakota county housing and redevelopment authority shall act and have exclusive jurisdiction for housing in the municipality pursuant to the provisions of the municipal housing and redevelopment act, Minnesota Statutes, Sections 462.411 to 462.711, and acts amendatory thereof. A transfer of duties relating to housing shall not transfer any duties relating to redevelopment.

Sec. 2. This act takes effect when approved by a majority of the board of county commissioners of Dakota county, and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 535—H.F.No.2244

An act relating to the city of Winona; authorizing the issuance of two additional on-sale liquor licenses.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. **WINONA, CITY OF; ADDITIONAL LIQUOR LICENSES.** Notwithstanding the limitations contained in Minnesota Statutes, Section 340.11, the city council of the city of Winona may, by unanimous action and after public hearing, issue not to exceed two licenses for the on-sale of intoxicating liquor in addition to the number authorized by section 340.11.

Sec. 2. This act is effective upon approval by the city council of the city of Winona, and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 536—H.F.No.2270

An act relating to the village of North St. Paul; authorizing the construction and financing of certain awnings in the village pursuant to Minnesota Statutes, Chapter 429.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. NORTH ST. PAUL, VILLAGE OF; PUBLIC AWNINGS. The village of North St. Paul may acquire, construct, reconstruct, improve, alter, extend, operate, maintain and promote awnings over all or part of the public sidewalks within the central business district in the village of North St. Paul and may adopt, make, assess and finance the same pursuant to the authority and procedures of Minnesota Statutes, Chapter 429.

Sec. 2. This act is effective upon its approval by the governing body of the village of North St. Paul and upon compliance with Minnesota Statutes, Section 645.021.

CHAPTER 537—H.F.No.2294

An act relating to the issuance of bonds by the village of Emmons.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. EMMONS, VILLAGE OF; FUNDING BONDS. The governing body of the village of Emmons may by resolution authorize the issuance and sale of general obligation bonds in a principal amount not to exceed \$30,000 for the purpose of funding currently outstanding warrants of the village. The bonds shall be issued and sold in accordance with Minnesota Statutes, Chapter 475, except that the bonds shall not be included in any calculation of net debt of the village pursuant to section 475.53 and may be sold by private negotiation if determined by the governing body to be in the best interests of the village.

Sec. 2. EFFECTIVE DATE. This act takes effect when approved by the governing body of the village of Emmons and upon compliance with the provisions of Minnesota Statutes, Section 645.021.
