

CHAPTER 704—S.F.No.1623

An act relating to privacy of communications; amending Minnesota Statutes 1971, Section 626A.05, Subdivision 2.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1971, Section 626A.05, Subdivision 2, is amended to read:

Subd. 2. **COMMUNICATIONS; OFFENSES FOR WHICH INTERCEPTION OF WIRE OR ORAL COMMUNICATION MAY BE AUTHORIZED.** A warrant authorizing interception of wire or oral communications by investigative or law enforcement officers may only be issued when such interception may provide evidence of the commission of any criminal felony offense involving murder, manslaughter, aggravated assault, aggravated robbery, kidnapping, aggravated rape, prostitution, bribery, perjury, theft, receiving stolen property, embezzlement, burglary, forgery, aggravated forgery, gambling, and offenses relating to ~~narcotic drugs controlled substances~~, or an attempt or conspiracy to commit any such offense or said offenses, as punishable under sections 609.185, 609.19, 609.195, 609.20, 609.225, 609.245, 609.25, 609.291, 609.32, subdivisions 1, 2, and 3, 609.42, 609.48, 609.52, 609.53, 609.54, 609.58, 609.625, 609.63, 609.76, 609.825, and ~~618.02~~ chapter 152.

CHAPTER 705—S.F.No.1633

An act relating to the Minnesota-Wisconsin boundary compact commission; appointment, compensation and reimbursement for Minnesota legislative advisory committee members; amending Minnesota Statutes 1971, Sections 1.34, Subdivision 1, and 1.36.

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1971, Section 1.34, Subdivision 1, is amended to read:

1.34 MINNESOTA-WISCONSIN BOUNDARY COMPACT COMMISSION; APPOINTMENT; EXPENSES; LEGISLATIVE

ADVISORY COMMITTEE. Subdivision 1. In order to assist the Minnesota-Wisconsin boundary area commission in the performance of its duties, there is created a legislative advisory committee comprised of five members of the house of representatives to be appointed by the speaker, and five members of the senate to be appointed by the committee on committees. The members of the advisory committee shall be selected before the close of any regular session of the legislature by January 31 of each odd numbered year. Vacancies, when the legislature is not in regular session, shall be filled by appointment of the last duly elected speaker, in the case of members of the house of representatives, and the last duly elected members of the committee on committees, in the case of members of the senate.

Sec. 2. Minnesota Statutes 1971, Section 1.36, is amended to read:

1.36 COMPENSATION AND REIMBURSEMENT FOR EXPENSES. Subdivision 1. Members of the commission and members of the advisory ~~committees~~ committee shall serve without compensation, but the actual and necessary expenses incurred by any member thereof in the performance of his duties shall be reimbursed from the appropriations made for the support of the commission by the state of Minnesota.

Subd. 2. Members of the legislative advisory committee shall be compensated and reimbursed for expenses in the same manner that members of legislative standing committees are compensated and reimbursed pursuant to Minnesota Statutes, Section 3.102.

Notwithstanding the provisions of any other law relating to notices of hearings and appeal procedures relating to special assessments, the city council of the city of St. Louis Park may by ordinance establish special assess-
