

Subd. 2. **ADOPTION OF SYMBOL.** The symbol adopted by Rehabilitation International's Eleventh World Congress shall be the state symbol indicating buildings and facilities accessible to and usable by persons in wheelchairs. In the interests of uniformity, it shall be the sole symbol for display in or on all public or private buildings and facilities which qualify for its use as determined by the governor's commission on employment of handicapped persons or its duly appointed representative. The secretary of state shall obtain and keep on file the symbol.

## CHAPTER 87—S.F.No.553

[Coded in Part]

*An act relating to state government operations; repealing the rural credit law and disposing of rural credit records; amending Minnesota Statutes 1971, Section 9.071; and Chapter 46, by adding a section; repealing Minnesota Statutes 1971, Chapter 41.*

Be it enacted by the Legislature of the State of Minnesota:

Section 1. Minnesota Statutes 1971, Section 9.071, is amended to read:

**9.071 RURAL CREDIT; REPEALER; SETTLEMENT OF CLAIMS; OTHER SPECIFIED POWERS.** The council has the powers with respect to the:

(1) Cancellation or compromise of claims due the state provided in Minnesota Statutes, Sections 10.11 to 10.15;

(2) Timberlands provided in Minnesota Statutes, Sections 90.031, 90.041, 90.151;

(3) Lands acquired from the United States provided in Minnesota Statutes, Section 94.50;

(4) Lands subject to delinquent drainage assessments provided in Minnesota Statutes, Section 84A.20;

(5) Transfer of lands between departments of state government provided in Minnesota Statutes, Section 15.16;

(6) Sale or exchange of lands within national forests provided in Minnesota Statutes, Sections 92.30, 92.31;

(7) Approval of acquisition of land for camping or parking area provided in Minnesota Statutes, Section 97.48;

(8) Modification of iron leases provided in Minnesota Statutes, Section 93.191;

(9) Awarding permits to prospect for iron ore provided in Minnesota Statutes, Section 93.17;

(10) Approval of regulations for issuance of permits to prospect for minerals under state lands provided in Minnesota Statutes, Section 93.08;

~~(11) Rural credit deficiency fund certificates of indebtedness provided in Minnesota Statutes, Section 41.37;~~

~~(12)~~ (11) Construction of dams provided in Minnesota Statutes, Section 110.13.

Sec. 2. Minnesota Statutes 1971, Chapter 46, is amended by adding a section to read:

**[46.22] RURAL CREDIT RECORDS.** The commissioner of banks shall have charge of the records of the former department of rural credit. He shall provide the public with appropriate access to and copies of the records.

Sec. 3. Minnesota Statutes 1971, Chapter 41, is repealed.
