All such vehicles shall display the distinctive license plates traditional with this conference, approved as to form and content by the governor.

Sec. 2. This act is in effect the day following its final enactment.

An act authorizing the annexation of certain state owned land by the city of Breckenridge.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. **BRECKENRIDGE, CITY OF; ANNEXATION OF LAND.** Notwithstanding any law to the contrary, the commissioner of highways may petition the city of Breckenridge to annex the following described lands in the county of Wilkin in the state of Minnesota which are owned by the state:

That part of the East half of the Northwest Quarter of Section 4, Township 132 North, Range 47 West, the West Half of the Southwest Quarter of Section 34, Township 133 North, Range 47 West, and Government Lots 2 and 3 of Section 33, Township 133 North, Range 47 West, all in Wilkin County, Minnesota described as follows:

Commencing at the west quarter corner of said Section 4; thence 91 degrees 46 minutes 31 seconds (azimuths are oriented to Minnesota State plane Coordinate System with 0 degrees 0 minutes 0 seconds being Grid North) along the east and west quarter line of said Section 4 a distance of 2067.32 feet to the point of beginning of the land to be described; thence 01 degrees 39 minutes 39 seconds, 2040.27 feet; thence 464.49 feet on a tangential curve concave to the west having a radius of 1859.86 feet and a central angle of 14 degrees 18 minutes 33 seconds to a point on the north line of said Section 4 distant 678.06 feet west of the north quarter corner thereof; thence 415.48 feet on a tangential curve concave to the west, having a radius of 1859.86 feet and a central angle of 12 degrees 47 minutes 58 seconds; thence 334 degrees 33 minutes 08 seconds on tangent to the last described curve, 896.84 feet; thence 244 degrees 33 minutes 08 seconds, 137.59 feet; thence 204 degrees 27 minutes 30 seconds, 273.50 feet; thence 359 degrees 58 minutes 41 seconds, 858.96 feet; thence on a non-tangential curve 127.82 feet, said curve is concave to the east, has a radius of 1959.86 feet, a central angle of 03 de-

minutes 31 seconds on the east and west quarter line of said Section 4 a distance of 141.07 feet to the point of beginning; containing 36.23 acres, more or less.

Sec. 2. Upon receipt of such petition from the commissioner, the city of Breckenridge by duly adopted resolution of its governing body is authorized to annex the above described property.

Sec. 3. This act is effective upon its approval by the governing body of the city of Breckenridge and upon compliance with the provisions of Minnesota Statutes, Section 645.021.

CHAPTER 105—H.F.No.2889

An act providing for certain positions to be in the unclassified service of the city of Minneapolis; amending Laws 1969, Chapter 937, Section 1, Subdivisions 1 as amended, 2, and 3, and by adding subdivisions.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Laws 1969, Chapter 937, Section 1, Subdivision 1, as amended by Laws 1973, Chapter 132, Section 1, is amended to read:

Section 1. **MINNEAPOLIS, CITY OF; PERSONNEL.** Subdivision 1. Notwithstanding any provisions of the Minneapolis city charter, veterans preference act, or civil service rule, law, or regulation to the contrary, the positions referred to in subdivisions 2 ; ~~3 and 4~~ to 6 of this section shall be in the unclassified service of the city of Minneapolis, and any person presently holding or who shall hereafter be appointed to any of such positions shall serve at the pleasure of the appointing authority indicated in the respective subdivision. Except as herein otherwise provided such persons shall be eligible for the same employee benefits as persons in the classified service.

Sec. 2. Laws 1969, Chapter 937, Section 1, Subdivision 2, is amended to read:

Subd. 2. The city council by a majority vote thereof may appoint not more than ~~three~~ five suitable persons as it may deem necessary to serve as administrative aides to the council and its presiding officer and may designate such positions by such titles as it shall determine.

Sec. 3. Laws 1969, Chapter 937, Section 1, Subdivision 3, is amended to read:

Subd. 3. The mayor of the city of Minneapolis may appoint a suitable person as his administrative deputy , and suitable persons not in excess of two as his administrative aides .
