**CHAPTER 136—S.F.No.2682****[Not Coded]**

*An act relating to the city of Upsala; validating certain proceedings of the city preliminary to and in the issuance and sale of certain general obligation bonds.*

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:**

**Section 1. UPSALA, CITY OF; BOND ISSUE; VALIDATING.** The proceedings of the city of Upsala, formerly the village of Upsala, taken in 1972 and 1973 for the making of a street and storm sewer improvement and the issuance of general obligation bonds therefor as described in a resolution adopted by the city council on November 6, 1972 are legalized and validated, notwithstanding any failure to comply with any of the requirements of Minnesota Statutes, Chapter 475. The action of the city council on October 15, 1973 and November 26, 1973, whereby pursuant to proper notice, the council sold general obligation bonds of the city to finance the aforementioned street and storm sewer improvement is also legalized and validated, and the bonds are valid and binding obligations of the city in accordance with their terms. The city is authorized to levy ad valorem taxes to pay the cost of payment of principal and interest on the bonds.

**Sec. 2.** This act takes effect when approved by the city council of the city of Upsala, and upon compliance with Minnesota Statutes, Section 645.021.

**CHAPTER 137—S.F.No.2718****[Not Coded]**

*An act directing the commissioner of natural resources to convey certain lands to Lake of the Woods county.*

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:**

**Section 1. CONVEYANCE OF STATE LANDS; LAKE OF THE WOODS COUNTY.** For the purpose of clearing the title thereto and validating a 1955 conveyance thereof, the commissioner of natural resources in the name of the state shall convey to Lake of the Woods county, without consideration by quitclaim deed in a form approved by the attorney general, all right, title and interest of the state in Government Lot 4, Section 3, Township 167 North, Range 33 West, in Lake of the Woods county.

Sec. 2. This act is effective the day following final enactment.

#### CHAPTER 138—S.F.No.2886

*An act relating to place of filing bonds of county officials; amending Minnesota Statutes 1971, Section 574.21.*

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1971, Section 574.21, is amended to read:

**574.21 COUNTIES; BONDS; FILING.** Except when otherwise especially provided by law, the bonds of public officials shall be filed as follows:

(1) Those of all state officers, including the officials and employees of the several departments and institutions thereof, with the secretary of state, who shall record and retain the same;

(2) Those of all county officers, and of all other officials or persons, given to the county, with the register of deeds ; ~~and after the same have been recorded by the register, he shall file them with the secretary of state for safekeeping ;~~

(3) Those of all city, village, and borough officers, with the clerk of such municipality;

(4) Those of school district officers, with the clerk of the district.

Sec. 2. This act shall take effect on the thirtieth day following its final enactment.
