An act relating to holidays; regulating the date for celebration of Veterans Day; amending Minnesota Statutes 1971, Section 645.44, Subdivision 5.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1971, Section 645.44, Subdivision 5, is amended to read:

Subd. 5. HOLIDAYS; VETERANS DAY. "Holiday" includes New Year's Day, January 1; Washington's and Lincoln's Birthday, the third Monday in February; Memorial Day, the last Monday in May; Independence Day, July 4; Labor Day, the first Monday in September; Christopher Columbus Day, the second Monday in October; Veterans Day, the fourth Monday in October-November 11; Thanksgiving Day, the fourth Thursday in November; and Christmas Day, December 25; provided, when New Year's Day, January 1; or Independence Day, July 4; or Veterans Day, November 11; or Christmas Day, December 25; falls on Sunday, the following day shall be a holiday and, provided, when New Year's Day, January 1; or Independence Day, July 4; or Veterans Day, November 11; or Christmas Day, December 25; falls on Saturday, the preceding day shall be a holiday. No public business shall be transacted on any holiday, except in cases of necessity and except in cases of public business transacted by the legislature, nor shall any civil process be served thereon.

Any agreement between a public employer and an employee organization citing Veterans Day as the fourth Monday in October shall be amended to cite Veterans Day as November 11.

  - Subd. 2. Blue Earth county: On the first Tuesday in October.
- Subd. 3. Brown county: On the first Tuesday in  $\frac{May}{March}$  and the second Tuesday in  $\frac{November}{September}$ .
- Subd. 4. Cottonwood county: On the first Tuesday in <u>May-March</u> and the second Tuesday in <u>November-October</u>.
- Subd. 5. Faribault county: On the first Tuesday in May and the second Tuesday in November.
- Subd. 6. Jackson county: On the first Tuesday in April and the second Tuesday in  $\frac{\text{September October}}{\text{October}}$ .
- Subd. 7. Lincoln county: On the first Tuesday in February May and the second Tuesday in September December .
- Subd. 8. Lyon county: On the first Tuesday in <u>May February</u> and the second Tuesday in <u>December September</u>.
- Subd. 9. Martin county: On the first Tuesday in March and the second Tuesday in October September.
- Subd. 10. Murray county: On the first Tuesday in April May and the second Tuesday in December.
- Subd. 11. Nicollet county: On the first Tuesday in  $\frac{March-April}{April}$  and the second Tuesday in  $\frac{September-October}{April}$ .
