**CHAPTER 90—S.F.No.1859**

*An act relating to courts; prescribing times for general terms of district court, fifth judicial district; amending Minnesota Statutes 1971, Section 484.13.*

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:**

Section 1. Minnesota Statutes 1971, Section 484.13, is amended to read:

**484.13 DISTRICT COURTS; FIFTH JUDICIAL DISTRICT.** Subdivision 1. General terms of district court in the counties named in this section shall be held each year at the time herein specified.

Subd. 2. Blue Earth county: On the first Tuesday in October.

Subd. 3. Brown county: On the first Tuesday in ~~May~~ March and the second Tuesday in ~~November~~ September .

Subd. 4. Cottonwood county: On the first Tuesday in ~~May~~ March and the second Tuesday in ~~November~~ October .

Subd. 5. Faribault county: On the first Tuesday in May and the second Tuesday in November.

Subd. 6. Jackson county: On the first Tuesday in April and the second Tuesday in ~~September~~ October .

Subd. 7. Lincoln county: On the first Tuesday in ~~February~~ May and the second Tuesday in ~~September~~ December .

Subd. 8. Lyon county: On the first Tuesday in ~~May~~ February and the second Tuesday in ~~December~~ September .

Subd. 9. Martin county: On the first Tuesday in March and the second Tuesday in ~~October~~ September .

Subd. 10. Murray county: On the first Tuesday in ~~April~~ May and the second Tuesday in December.

Subd. 11. Nicollet county: On the first Tuesday in ~~March~~ April and the second Tuesday in ~~September~~ October .

Subd. 12. Nobles county: On the first Tuesday in February and the second Tuesday in ~~October~~ September .

Subd. 13. Pipestone county: On the first Tuesday in April and the second Tuesday in November.

Subd. 14. Redwood county: On the first Tuesday in March and the second Tuesday in October.

Subd. 15. Rock county: On the first Tuesday in ~~March~~ April and the second Tuesday in ~~September~~ November .

Subd. 16. Watonwan county: On the first Tuesday in ~~April~~ May and the second Tuesday in ~~October~~ November .

Sec. 2. This act shall take effect September 1, 1974.

**CHAPTER 91—S.F.No.2256**

*An act relating to the park board of the city of Minneapolis; authorizing municipalities, other than the city of Minneapolis, to levy special assessments on property within such municipalities which has been benefitted by public improvements made by the park board of the city of Minneapolis and to pay over such money to such park board.*

**BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:**

**Section 1. MINNEAPOLIS, CITY OF; PARK BOARD; PUBLIC IMPROVEMENT TO PROPERTY IN OTHER MUNICIPALITIES.** Whenever the park board of the city of Minneapolis undertakes any public improvement to be financed in whole or in part by levying special assessments against the property benefitted, and when any of the property benefitted is in a municipality, other than the city of Minneapolis, such municipality may determine the amount of the benefits to such property, which property may include property owned or under the control of the municipality or its residents. Such determination shall be made only after such municipality has held a public hearing on the proposed assessment. After such hearing the municipality may levy a special assessment in the amount of the benefits against such property.

**Sec. 2. PAYMENT OF SPECIAL ASSESSMENT.** After the hearing on the proposed assessment and levy of the assessment, the city or village council may pay the amount or any portion thereof so determined to be of benefit to it or its residents, to the park board of the city of Minneapolis. Any amounts paid hereunder may be paid in annual installments for the number of years that the city has levied the special assessment for the public improvement.
