## CHAPTER 213-H.F.No.119

An act relating to the practice of medicine; physicians, surgeons and osteopaths; suspension of license; amending Minnesota Statutes 1974, Section 147.021, Subdivision 2.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MIN-NESOTA:

Section 1. Minnesota Statutes 1974, Section 147.021, Subdivision 2, is amended to read:

Subd. 2. HEALTH; PHYSICIANS, SURGEONS AND OSTEO-PATHS; SUSPENSION OF LICENSE. A suspension, revocation, condition, limitation, qualification or restriction of a license shall be in effect pending determination of an appeal unless the court, upon petition and for good cause shown, shall otherwise order.

A license to practice medicine is suspended if (1) a guardian of the person of a licensee is appointed by order of a probate court pursuant to sections 525.54 to 525.612, for reasons other than the minority of the licensee; or (2) the licensee is committed by order of a probate court pursuant to sections 253A.01 to 253A.21 or 526.09 to 526.11. The license remains suspended until the licensee is restored to capacity by a court and, upon petition by the licensee, the suspension is terminated by the board after a hearing. A license to practice medicine is also suspended when a licensee is convicted of the crime of abortion and remains suspended until, upon petition by the licensee, the suspension is terminated by the board after a hearing.

When a probate court or other court of competent jurisdiction appoints a guardian of the person of a licensee pursuant to sections 525.54 to 525.612 for reasons other than the minority of the licensee or commits a licensee pursuant to sections 253A.01 to 253A.21 or 526.09 to 526.11, the probate court or other court of competent jurisdiction shall promptly notify the board in writing of the fact.

## CHAPTER 214-H.F.No.142

An act adding a new route to the trunk highway system.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MIN-NESOTA:

Section 1. [161.115] TRUNK HIGHWAYS; ADDITIONAL ROUTE ADDED TO TRUNK HIGHWAY SYSTEM. There is hereby added to the trunk highway system a new route described as follows:

Route No. 333. Beginning at a point on Route 392 in Hennepin county, thence extending in a generally easterly direction to a point on Route 394 in Anoka or Ramsey county.

Sec. 2. The revisor of statutes is directed to assign a number to such route and compile the same in the next edition of the Minnesota Statutes.

Sec. 3. Notwithstanding any other law to the contrary, the commissioner of highways upon completion of construction of the route described in section 1, is authorized to turn back to the appropriate counties and/or municipalities portions of existing trunk highways lying within the counties through which the route described in section 1 passes. The aggregate mileage to be turned back shall be substantially the same as the mileage of the route described in section 1. Trunk highways to be turned back shall be designated by the commissioner of highways.

Sec. 4. The counties and municipalities through which the route described in section 1 passes, are hereby authorized to expend their respective share of highway user funds or such other funds available to them for highway or street purposes for planning, preliminary engineering and right-of-way acquisition for said route. The commissioner shall not proceed with right-of-way acquisition or construction of the route described in section 1 unless federal aid requirements have been met and federal aid highway funds are made available for said route. Moneys expended by local governmental units for planning, preliminary engineering and right-of-way acquisition including all related acquisition costs shall be reimbursed by the governmental unit authorizing construction at the time of authorization.
