An act relating to employment; authorizing employment of certain persons by the state and other governmental units; authorizing the state to insure its liability under workmen's compensation for certain persons employed by it; amending Minnesota Statutes 1974, Sections 15.61; and 176.541, by adding a subdivision.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 1974, Section 15.61, is amended to read:

- 15.61 FEDERAL EMPLOYMENT ACTS; UNEMPLOYED AND UNDEREMPLOYED; EMPLOYMENT BY STATE AND OTHER GOVERNMENTAL UNITS. Subdivision 1. The state of Minnesota, its departments, agencies and instrumentalities, and any county, city, town, school district or other body corporate and politic, may employ unemployed and underemployed persons as defined in the federal Comprehensive Manpower Training and Employment Act of 1973, Title Hemergency Employment Act of 1971, as amended, and Comprehensive Employment and Training Act of 1973, as amended, pursuant to and in accordance with the terms of that act those acts.
- Subd. 2. The provisions of Minnesota Statutes 1969, Sections 197.45 to 197.48 and 43.30 and any other law or ordinance relating to preference in employment and promotion of persons having served in the armed services, the provisions of any eivil service law, rule or regulation, the provisions of any city charter or any ordinance or resolution, or the provisions of any other law or statute in conflict with the provisions of the federal Comprehensive Manpower Training and Employment Act of 1973, Title H Emergency Employment Act of 1971, as amended, and Comprehensive Employment and Training Act of 1973, as amended, shall not be applicable to the employment of the persons specified in subdivision 1.
- Subd. 3. The provision of any law limiting the complement of any state department or agency is not applicable to persons employed pursuant to this section and the provisions of the federal Comprehensive Manpower Training and Employment Act of 1973, Title H-Emergency Employment Act of 1971, as amended, and Comprehensive Employment and Training Act of 1973, as amended, when such employment by a state department or agency has been approved by the commissioner of administration: and after the governor has consulted the legislative advisory committee and such committee has made its recommendation thereon. Such recommendation shall be advisory only. Failure or refusal of the committee to make a recommendation promptly shall be deemed a negative recommendation.

- Subd. 8. STATE MAY INSURE. The state of Minnesota may elect to insure its liability under the workmen's compensation law for persons employed under the federal Emergency Employment Act of 1971, as amended, and the Comprehensive Employment and Training Act of 1973, as amended, with an insurer properly licensed in Minnesota.
- Sec. 3. EFFECTIVE DATE. This act is effective the day following its final enactment.

CHAPTER 3—S.F.No.64

An act relating to veterans affairs, providing additional money for veterans bonus payments; appropriating money.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

- Section 1. VIETNAM BONUS, ADDITIONAL APPROPRIATION. There is hereby appropriated to the veterans adjusted compensation fund from the general fund \$5,000,000 or so much thereof as may be necessary, for paying adjusted compensation to Vietnam veterans under the provisions of Minnesota Statutes 1974, Sections 197.971 to 197.986.
- Sec. 2. This appropriation is exempted from all provisions of chapters 16 and 16A covering cancellation of funds and shall not lapse at the end of any fiscal year but shall be reappropriated for the following fiscal year and shall expire December 31, 1976.
- Sec. 3. This act shall be effective the day following final enactment.
